bounded and described as follows:

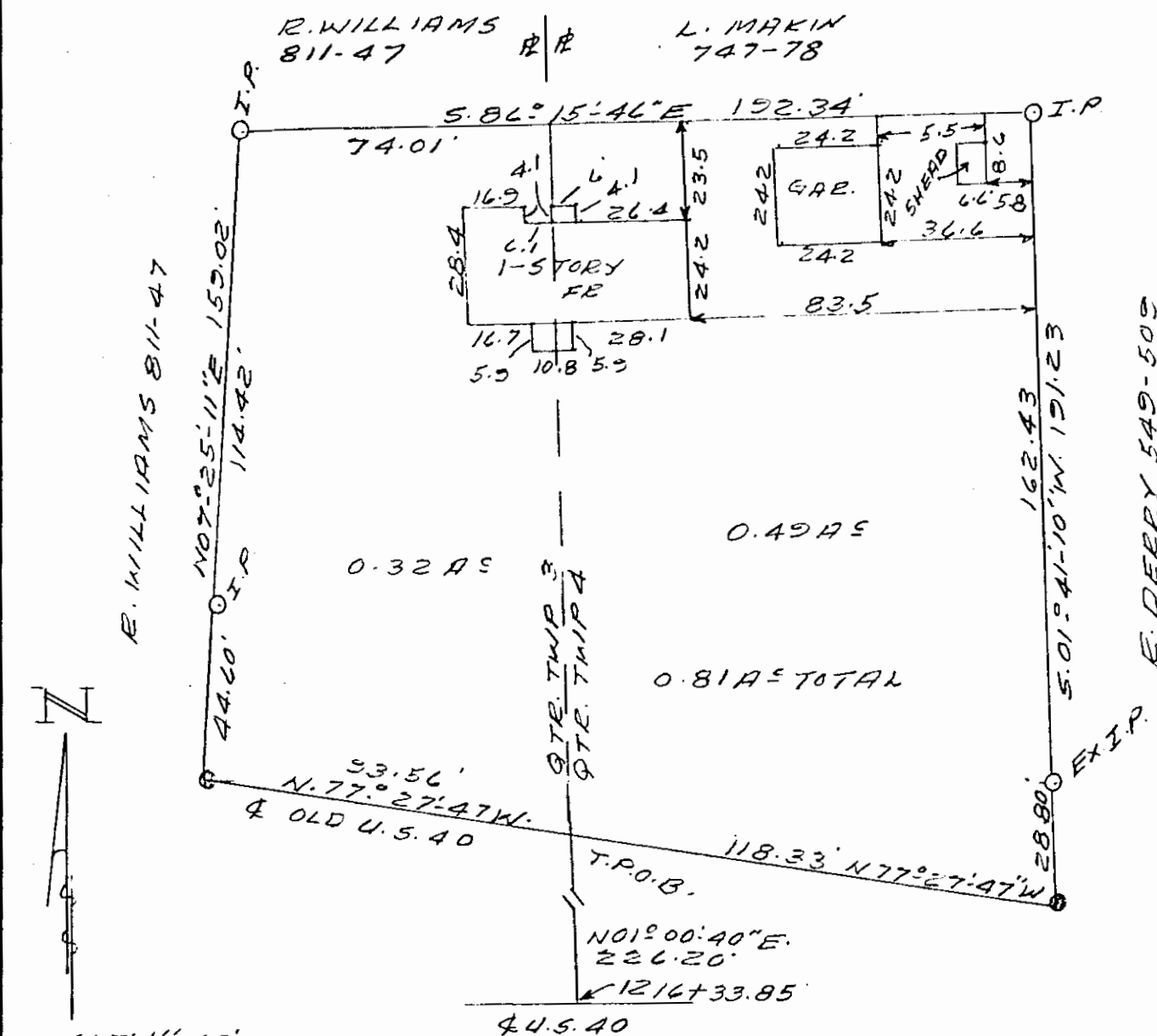
Commencing at a point in the centerline of State Route 40 at

of 93.56 feet to a point; thence north 07 degrees 25 minutes 11 seconds

Williams and recorded in deed book 811, page 47 of the deed records
of said county a distance of 159.02 feet to an iron pin and passing
