Situated in the State of Ohio, County of Muskingum, Township of Falls.

Being a part of the Third Quarter, Township 1, Range 8 bounded and described as follows:

Commencing at the southeast corner of Lot 1 of Monroe and Duncan's Subdivision and the northeast corner of Lot 1 of Williams Subdivision as is recorded in Record X, Page 459 of the Common Pleas Records; thence south along the east line of Lot 1 of Williams Subdivision a distance of 743.16 feet to a point in the intersection of Jersey Ridge Road and Dillon Falls Road; thence along the center of said Dillon Falls Road north 25 degrees 23 minutes east 248.78 feet to the true place of beginning of the premises herein intended to be described; thence continuing along the center of said road north 25 degrees 23 minutes east 89.22 feet to a point; thence continuing along said centerline north 21 degrees 19 minutes east 161.38 feet to a point; thence leaving said centerline south 70 degrees 44 minutes east 415.38 feet to an iron pin; thence south 15 degrees 51 minutes west 77.81 feet to an iron pin; thence south 9 degrees 19 minutes west 174.96 feet to an iron pin; thence north 70 degrees 44 minutes west 465.53 feet to the true place of beginning, containing two and fifty hundredths (2.50) acres more or less.



