Situated in the County of Muskingum, in the State of Ohio, and in the Township of Falls, bounded and described as follows:

Being in the Third Quarter of the First Township, Eighth Range of the United States Military Lands:

Commencing, for reference, at the intersection of the East line of said Quarter Township 3, Township 1, Range 8, and the center of the old location of the National Road (U.S. Route #40); thence run North 78 degrees 00 minutes West on the centerline of said road a distance of 747.5 feet to a point on said centerline; thence North 01 degree 14 minutes West a distance of 231.14 feet to an existing iron pipe, which is the Place of Beginning of the property herein intended to be described; thence run North 78 degrees 00 minutes West a distance of 128.64 feet to an iron pin; thence North 11 degrees 00 minutes West a distance of 161.20 feet; thence North 00 degrees 15 minutes East a distance of 153.05 feet to the North property line of this grantors property; thence South 78 degrees 33 minutes East a distance of 152.32 feet to the Northeast corner of this grantors property; thence South 01 degree 14 minutes East a distance of 307.86 feet to the Place of Beginning containing 1.021 acre, more or less.




