(United States Route forty); thence North 74 degrees 30 minutes
00 seconds West 1301.98 feet along the centerline of the said
Old National Road to a point, said point being the place of beg-
inning of this tract; thence continuing North 74 degrees 30 min-
utes 00 seconds West 142.67 feet along the said centerline of
the Old National Road; thence leaving the said centerline
North 02 degrees 33 minutes 27 seconds East 257.64 feet to a
point marked by an iron pin, said point being south 02 degrees

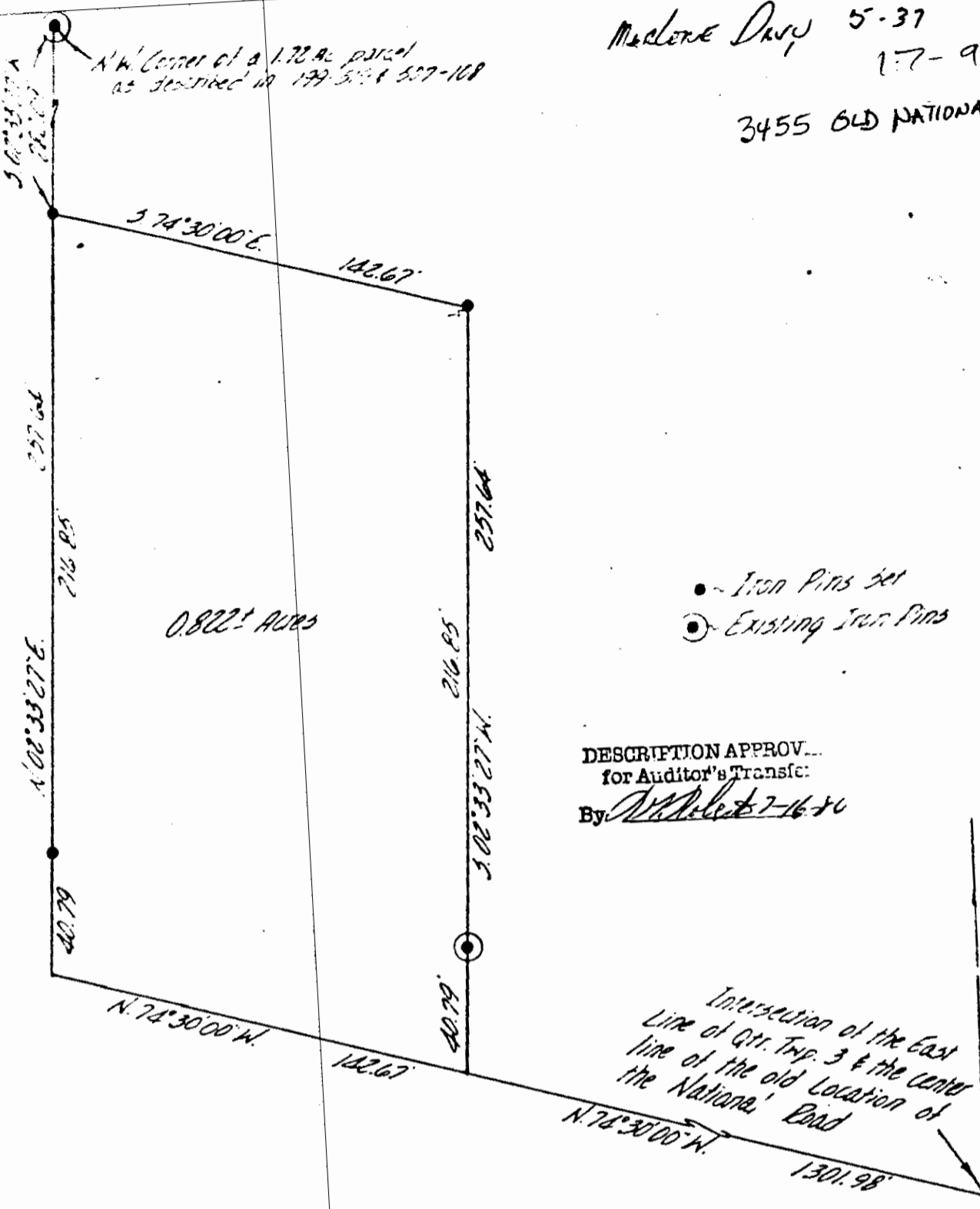
