### EAGLEVIEW APTS. TO COMMUNITY INV. CORP.

Situated in the State of Ohio, County of Muskingum, Township of Falls, bounded and described as follows:

Being a part of the southeast quarter of Quarter Township 3, Township 1 North, Range 8 West, United States Military Lands, and being more particularly described as follows:

Beginning for reference at a monument found at Interstate 70 centerline station 1212+00.00 as the same is designated and delineated on Muskingum County Plat Book 11, Pages 47 and 48;  
 thence along said centerline on a curve to the left having a radius of 3906.53 feet, a central angle of 01 degrees 39 minutes 26 seconds and a chord bearing South 85 degrees 36 minutes 22 seconds West a distance of 112.99 feet to centerline station 1210+87.01;  
 thence North 05 degrees 12 minutes 07 seconds East 157.50 feet to a wooden post found on the north right of way of Interstate 70, 155.00 feet left of centerline station 1211+14.40;  
 thence along the north right of way of Interstate 70 the following four courses:  
 1) North 76 degrees 13 minutes 52 seconds West 149.21 feet to a point;  
 2) South 78 degrees 51 minutes 47 seconds West 189.46 feet to a point;  
 3) South 70 degrees 03 minutes 28 seconds West 358.18 feet to a point;  
 4) South 76 degrees 20 minutes 32 seconds West 358.21 feet to an iron pin found 165.54 feet left of centerline station 1201+15.94;  
 thence along the east line of a tract of land now owned by J. and M. Brown (DR 1079-516) North 04 degrees 50 minutes 22 seconds East 228.72 feet to an iron pin found on the south line of lands now owned by Community Investment Corporation (DR 1127-540);  
 thence through said Community Investment's lands North 04 degrees 50 minutes 22 seconds East 139.00 feet to an iron pin set and the principal place of beginning;  
 thence North 60 degrees 37 minutes 56 seconds West 262.45 feet to an iron pin set;  
 thence North 62 degrees 37 minutes 21 seconds West 320.00 feet to an iron pin set;  
 thence North 68 degrees 07 minutes 30 seconds West 209.01 feet to an iron pin set;  
 thence North 69 degrees 01 minutes 16 seconds West 251.00 feet to a point in Kopchak Road (TR-422), passing an iron pin set at 221.00 feet;  
 thence along Kopchak Road (TR-422) North 33 degrees 29 minutes 32 seconds East 71.07 feet to a point;  
 thence leaving Kopchak Road (TR-422) South 69 degrees 01 minutes 16 seconds East 236.15 feet to an iron pin set, passing an iron pin set at 30.00 feet;  
 thence South 68 degrees 07 minutes 30 seconds East 212.89 feet to an iron pin set;  
 thence South 62 degrees 37 minutes 21 seconds East 324.54 feet to an iron pin set;  
 thence South 60 degrees 37 minutes 56 seconds East 236.90 feet to an iron pin set;

thence South 08 degrees 16 minutes 44 seconds West 74.36 feet to an iron pin set and the principal place of beginning;

containing 1.63 acres more or less, subject to all legal road right of ways and applicable easements, written or implied.

Iron pins set are 5/8 inch by 30 inch long rebar with a plastic identification cap.

Bearings are based on the centerline of Interstate 70 as designated in Muskingum County Plat Book 11 Pages 47 and 48.




