5.57 ACRES

Situated in the State of Ohio, County of Muskingum, Township of Falls, bounded and described as follows:

Being a part of the southeast quarter of Quarter Township 3, Township 1 North, Range 8 West, United States Military Lands, and being more particularly described as follows:

Beginning for reference at a monument found at Interstate 70 centerline station 1212+00.00 as the same is designated and delineated on Muskingum County Plat Book 11, Pages 47 and 48;

thence along said centerline on a curve to the left having a radius of 3906.53 feet, a central angle of 01 degrees 39 minutes 26 seconds and a chord bearing South 85 degrees 36 minutes 22 seconds West a distance of 112.99 feet to centerline station 1210+87.01;

thence North 05 degrees 12 minutes 07 seconds East 157.50 feet to a wooden post found on the north right of way of Interstate 70, 155.00 feet left of centerline station 1211+14.40 and the southeast corner of lands now owned by Community Investment Corporation (DR 1127-540), said point being the principal place of beginning;

thence along the north right of way of Interstate 70 and the south line of Community Investment Corporation's lands the following two courses:

- 1) North 76 degrees 13 minutes 52 seconds West 149.21 feet to a point;
- 2) South 78 degrees 51 minutes 47 seconds West 189.46 feet to a point;

thence through said Community Investment Corporation's lands North 14 degrees 45 minutes 54 seconds West 710.33 feet to an iron pin on the south right of way of US Route 40, passing an iron pin found at 246.22 feet;

thence along said south right of way of US Route 40 South 68 degrees 44 minutes 46 seconds East 595.12 feet to a point on the west line of lands now owned by Russell E., Sr. and Carolyn M. Scott, Co-Trustees (DR 1890-149);

thence along said Scotts' west line South 05 degrees 12 minutes 07 seconds West 472.01 feet to the principal place of beginning, containing 5.57 acres more or less, subject to all legal road right of ways and applicable easements, written or implied.

Bearings are based on the centerline of Interstate 70 as designated in Muskingum County Plat Book 11 Pages 47 and 48.



Bearings are based on the centerline of Interstate 70, as per Plat Book 11, Pages 47 and 48.




