BEING A PART OF LOT 210 OF LICKING VIEW (PLAT BOOK 5, PAGE 97 OF THE MUSKINGUM COUNTY PLAT RECORDS) AND A PART OF THE TRACT CONVEYED TO JACK AND DELORES SNIDER (DEED BOOK 1110, PAGE 22 OF THE MUSKINGUM COUNTY DEED RECORDS), SITUATED IN QUARTER TOWNSHIP 4, TOWNSHIP 1, RANGE 8, OF THE UNITED STATES MILITARY LANDS, FALLS TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN SET AT THE SOUTHWEST CORNER OF LOT 210 OF SAID LICKING VIEW;

THENCE WITH THE WEST LINE OF LOT 210 OF LICKING VIEW, NORTH 20 DEGREES 34 MINUTES 18 SECONDS EAST 473.17 FEET TO A POINT AT THE NORTHWEST CORNER OF SAID LOT, PASSING AN IRON PIN SET AT 423.17 FEET;

THENCE WITH THE NORTH LINE OF LOT 210, SOUTH 27 DEGREES 59 MINUTES 17 SECONDS EAST 212.10 FEET TO A POINT IN HIGHLAND ROAD;

THENCE WITH THE WEST LINE OF THE SAID ZANESVILLE TERRACE TRACT, SOUTH 30 DEGREES 17 MINUTES 01 SECONDS WEST 490.00 FEET TO AN EXISTING IRON PIN (1/2 INCH PIPE) AT THE NORTHEAST CORNER OF A TRACT CONVEYED TO M.L. BIEDENBACH, TRUSTEE IN O.R. VOLUME 1542, PAGE 713;

THENCE LEAVING THE SAID ZANESVILLE TERRACE WEST LINE AND WITH THE NORTH LINE OF THE SAID BIEDENBACH TRACT, NORTH 65 DEGREES 37 MINUTES 58 SECONDS WEST 326.09 FEET TO AN EXISTING IRON PIN (1/2 INCH PIPE);

THENCE WITH THE EAST LINE OF THE KESSLER TRACT, NORTH 24 DEGREES 28 MINUTES 51 SECONDS EAST 1127.47 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR) ON THE SOUTH LINE OF LOT 212 OF LICKING VIEW, PASSING EXISTING IRON PINS AT 72.98 FEET (5/8 INCH REBAR), 660.77 FEET (3/4 INCH PIPE) AND AN IRON PIN SET AT 946.57 FEET;

THENCE WITH THE SOUTH LINE OF LOT 212 AND LOT 211 OF LICKING VIEW, SOUTH 75 DEGREES 07 MINUTES 19 SECONDS EAST, PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 47.93 FEET, A TOTAL DISTANCE OF 243.05 FEET TO THE PLACE OF BEGINNING.




