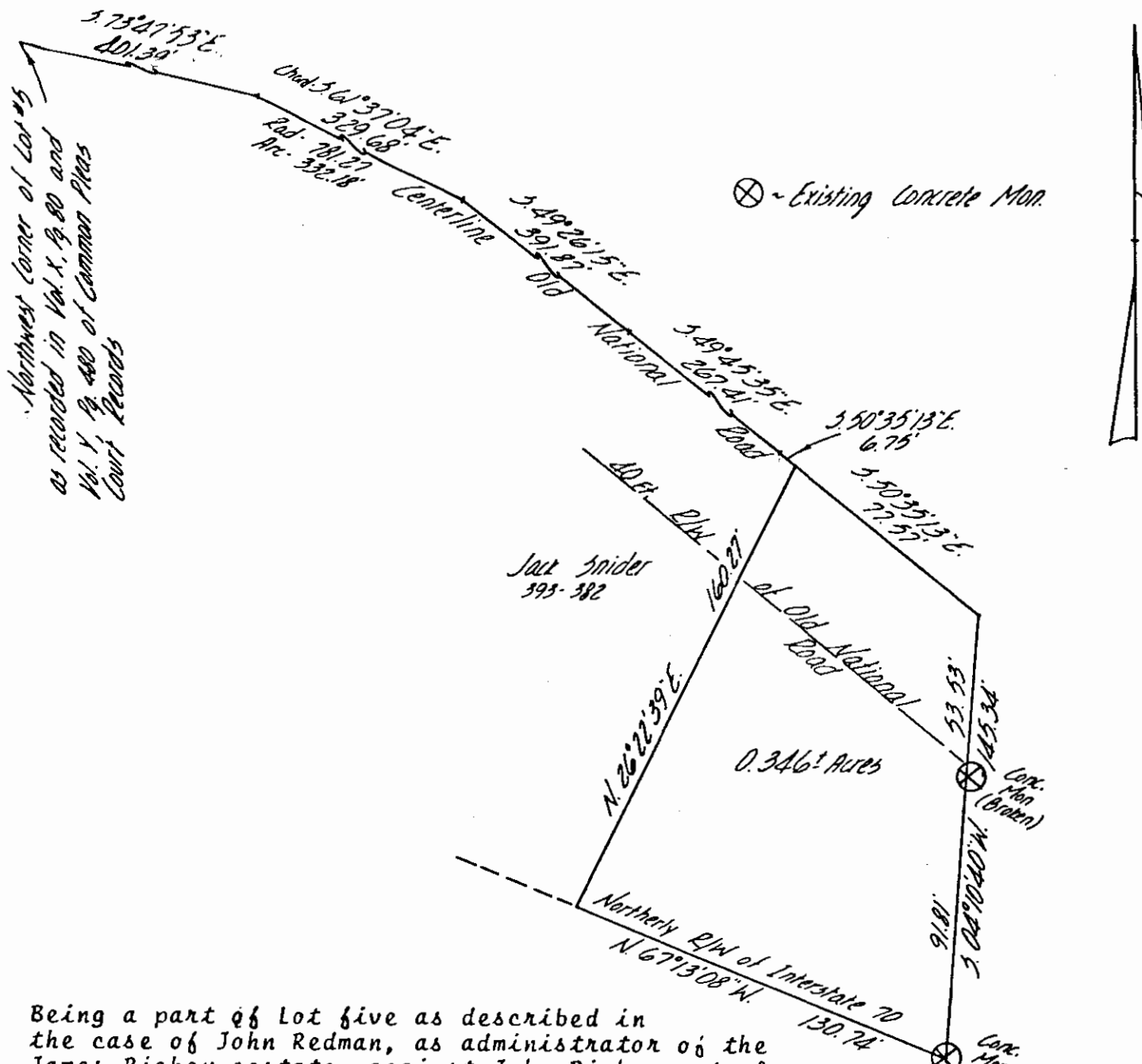
Commencing at the Northwest Corner of Lot number five as described in the case of John Redman, as administrator of the James Rieney estate, against John Rieney, et, al as recorded in Common Pleas Court Records, in Volume X, page 80 and Volume Y, page 480 of the Muskingum County; thence along the North Line of said lot five and the center of the Old National Road South 73 degrees 47 minutes 53 seconds East 401.39 feet to a point; thence continuing along said centerline on a curve to the right having a radius of 781.27 feet an arc distance of 332.18 feet (the chord of which bears South 61 degrees 37 minutes 04 seconds East 329.66 feet) to a point; thence continuing along said centerline South 49 degrees 26 minutes 15 seconds East 391.87 feet to a point in the center of said road; thence continuing along said centerline South 49 degrees 45 minutes 35 seconds East 267.41 feet to a point in the center of said road; thence continuing along said centerline South 50 degrees 35 minutes 13 seconds East 6.75 feet to a point in the center of said road said point being the place of beginning of the tract herein intended to be described; thence continuing along said centerline South 50 degrees 35 minutes 13 seconds East 77.57 feet to a point in the center of said road; thence leaving said road South 84 degrees 10 minutes 40 seconds West 145.34 feet to a point on the Northerly right-of-way line of Interstate seventy marked by an existing concrete monument, passing a point marked by an existing concrete monument (broken) at 53.53 feet; thence along said right-of-way North 67 degrees 13 minutes 08 seconds West 130.74 feet to a point; thence leaving said right-of-way North 26 degrees 22 minutes 39 seconds East 160.27 feet to the place of beginning.
