

DEED DESCRIPTION

Sidwell

Being a part of Quarter Township 4, Township 1 North, Range 8 West, Falls Township, Muskingum County, Ohio and being a part of the lands of Fred A. Rehl, et al, Volume 169, Page 467, Parcel # 17-96-02-05-000 and being more particularly described as follows:

Beginning, for reference, at a stone found at the southwest corner of Quarter Township 4; thence North 58° 24' 55" East 2670.75 feet to an iron pin set and the principal place of beginning of the tract herein to be described; thence North 02° 29' 09" East 172.28 feet to an iron pin set on the south right-of-way line of I-70; thence South 59° 17' 53" East 363.83 feet to an iron pin set on the south right-of-way line of I-70; thence North 87° 33' 40" West 320.60 feet to the place of beginning. The tract as surveyed contains 0.63 acres, more or less, subject to all highways and easements of record.

Bearings in the above description are based on the south line of Falls Township bearing North 87° 25' 41" West.

Iron pins set are 5/8 inch rebar, 30 inches long with plastic identification caps set flush with the ground.


