

DESCRIPTION OF SURVEY FOR BILL HILL

JOB #324-2

Situated in the State of Ohio, County of Muskingum, Township of Falls, Fourth Quarter, of Township #1, Range #8, of the U.S. Military District:

Being part of Parcel #15, of the prior deed reference Volume 246, Page 557, of said county's deed records, also being part of Muskingum County Auditor's Parcel Number 17-17-99-01- -000 and more particularly described as follows;

Beginning at the intersection of the South right-of-way line for Interstate #70 and the center line for existing County Road #414 (Licking Road), said point being 73.99 feet right of Station #74+44.09 of the center line survey for said Interstate #70 as shown on the Location Survey Plat recorded in Plat Book 10, Page 23, as established by monumentation (found) and herein described,
#1- thence along the center of said County Road S 53 55 00 E 95.89 feet to the PC of a curve;
#2- thence continuing along said road and with a curve to the right having, a Radius of 716.20 feet, an Arc length of 445.52 feet, and a Chord bearing of S 36 05 45 E 438.37 feet to the PT of said curve;
#3- thence continuing along said county road S 18 16 30 E 210.77 feet to the center point of a bridge crossing Timber Run Creek;
#4- thence S 67 46 10 W 23.01 feet to a point on the North line of the Replat of Pataskala Heights Acreage as recorded in Plat Book 7, Pages 62 & 63 of said county's plat records, and on the West right-of-way line for former County Road #414, said point also being with said Timber Run Creek;

thence along the West line of said former County Road #414 the following seven courses-

- #5- N 16 12 48 W 43.99 feet to a point from which an iron pipe (found) in a stone dam for reference bears N 71 07 43 W 18.93 feet;
- #6- N 28 46 18 W 87.64 feet to a point from which an iron pin (set) for reference bears N 58 22 43 E 11.64 feet;
- #7- N 41 19 48 W ~~356.08~~ 354.08 feet to a concrete monument (found) at the Southeast corner of Old Quaker Cemetery;
- #8- N 41 19 48 W 136.52 feet to an iron pin (set);
- #9- along a curve to the left having, a Radius of 1407.7 feet, an Arc length of 69.93 feet, and a Chord bearing N 42 30 58 W 69.93 feet to a concrete monument (found);
- #10- along a curve to the left having a Radius of 1407.7 feet, an Arc length of 34.78 feet, and a Chord bearing N 44 19 09 W 34.77 feet to a concrete monument (found) 124.30 feet right of Station 73+69.70 of said interstate #70;
- #11- also along a right of way for said interstate #70 N 46 20 05 W 64.23 feet to a concrete monument (found) 75.00 feet right of Station 73+25.4 of said interstate #70;
- #12- thence along the South line of said Interstate #70 toward a concrete monument (found) at 67.00 feet right of Station 76+41.50 of said Interstate #70 N 84 25 34 E 116.47 feet to the place of beginning, passing an iron pin (set) at 79.38 feet, containing 1.539 acres, all within the right-of-ways for existing and former County Road #414.

The bearings within this description are based on State Plane Coordinate Grid, derived from a Solar Observation (Local Hour Angle Method). Iron pins (set) are 5/8" rebar with aluminum identification caps (C.R.Harkness R.S.6885).






