Being part of Quarter Township 4 of Township 1, Range 8, in Falls Township, County of Muskingum, and the State of Ohio, and bounded and described as follows:

Commencing at an iron pin at the southwest corner of Lot 8 of Mack Ingram's Subdivision (Plat Book 11 Page 3);
thence North 76 degrees 48 minutes 05 seconds West 690.02 feet to an iron pin set, said point also being the place of beginning for the following described parcel;

thence along the west line of a property owned by Sanpon Inc. (DR 1010-161) South 27 degrees 44 minutes 07 seconds West 147.70 feet to a pipe found;
thence along a north line of a property owned by Sanpon Inc. (DR 1010-161, 1006-65) North 87 degrees 23 minutes 00 seconds West 243.00 feet to a point in the centerline of Rehl Road, passing an iron pin found at 223.32 feet;
thence along the centerline of Rehl Road the following three courses:
1.) North 16 degrees 54 minutes 54 seconds East 89.00 feet to a point;
2.) North 26 degrees 45 minutes 03 seconds East 89.00 feet to a point;
3.) North 25 degrees 14 minutes 26 seconds East 114.50 feet to a point;
thence leaving the centerline of Rehl Road and along the south line of V. Morgan (DR 1072-313) South 52 degrees 56 minutes 22 seconds East 246.50 feet, passing an iron pin found at 12 feet to the place of beginning, containing 1.20 acres, more or less.




