Situated in the State of Ohio, County of Muskingum, Township of Falls, bounded and described as follows:

Being a part of Fourth Quarter of Township One North, Range Eight West, United States Military Lands, and more particularly described as follows:

Beginning at an axle found on the Southwest Corner of Lot 6 of Mack Ingram's Subdivision as the same is designated and delineated on Muskingum County Plat Book 11, Page 3 and the northwest corner of lands now owned by R. Kuhn (Deed Record 1013-551); thence along Kuhn's west line South 46 degrees 12 minutes 30 seconds West 210.38 feet to an iron pin found on Kuhn's southwest corner; thence continuing along said line South 46 degrees 12 minutes 30 seconds West 90.02 feet to an iron pin found on the north line of lands now owned by Sanpon, Inc. (Deed Record 1010-161); thence along said Sanpon's north line North 54 degrees 24 minutes 36 seconds West 331.27 feet to an iron pipe found; thence North 45 degrees 20 minutes 34 seconds West 28.66 feet to an iron pipe found; thence North 51 degrees 48 minutes 35 seconds West 87.80 feet to an iron pipe found on the south east corner of lands now owned by T. Holbein and S. Davis (Deed Record 1061-504); thence along Holbein and Davis's east line North 45 degrees 47 minutes 43 seconds East 100.15 feet to an iron pin set on the south line of lands now owned by C.B. and S.A. Mudgett (Deed Record 876-228); thence along Mudgett's south line South 51 degrees 41 minutes 43 seconds East 74.28 feet to an iron pipe found; thence North 45 degrees 28 minutes 44 seconds East 107.00 feet to an iron pin set on Mudgett's northeast corner; thence along Mudgett's north line North 51 degrees 40 minutes 39 seconds West 225.00 feet to an iron "T" post found on the east right-of-way line of Rehl Road (County Road 472); thence along said east right-of-way line North 45 degrees 46 minutes 07 seconds East 219.90 feet to an iron pipe found on the southeast corner of lands now owned by Board of Education of Falls Township (Deed Record 443-233 and Deed Record 494-99); thence along said Board of Education's south line South 51 degrees 21 minutes 58 seconds East 499.47 feet to a concrete monument found on said Board's southeast corner; thence continuing along said line South 51 degrees 21 minutes 58 seconds East 100.03 feet to an iron pipe found on the southeast corner of lands now owned by R. Fleer (Deed Record 1068-539); thence South 46 degrees 12 minutes 30 seconds West 110.93 feet to the southwest corner of lands now owned by S.W. Sawicki (Deed Record 777-03) and the place of beginning, containing 4.86 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.





