DESCRIPTION OF SURVEY FOR T PINKERTON

Situated in the State of Ohio, County of Muskingum, Township of Falls:

Being part of the Fourth Quarter Township, of Township #1, Range #8, of the US Military District, being part of the B Barnhart property described in deed reference Deed Book Volume 1041, Page 221 of said county's deed records, known as Muskingum County Auditor's Parcel Number 17-98-02-15-000, and more particularly described as follows;

Commencing at an iron pipe (found) at the Southern corner for Lot #123 of Licking View as recorded in Plat Book 5, Page 93, also being the Northern intersection of Rehl Road (County Road #472) and Highland Road; **thence S 45 57 40 W 981.26 feet** along the Northwestern line of Rehl Road to an iron pipe (found) at a common corner for the Muskingum County Board of Commissioners property recorded in deed reference Deed Book Volume 658, Page 334 and the E & S Strauss property recorded in deed reference Deed Book Volume 537, Page 271; **thence N 59 23 10 W 250.00 feet** leaving said road and along a common line for said County and Strauss properties to an iron pin (set) at a common corner for said County and Strauss properties; **thence S 33 58 50 W 100.32 feet** along a common line for said County and Strauss properties to an iron pin (set) at a common corner for said County, Strauss, and Barnhart properties, also being the place of beginning for the property herein intended to be described;

- #1- **thence S 54 47 00 E 20.90 feet** along a common line for said Strauss and Barnhart properties to an iron pin (set);
- #2- **thence along a curve to the right** having a chord bearing **S 14 54 10 E 157.52 feet**, a radius of 122.78 feet and arc length of 171.01 feet along a common line for said Strauss and Barnhart properties to an iron pipe (found);
- #3- **thence S 24 42 30 W 28.86 feet** along a common line for said Strauss and Barnhart properties to an iron pin (set);
- #4- **thence N 61 27 00 W 15.72 feet** into said Barnhart property to an iron pin (set);
- #5- **thence N 26 08 40 E 27.89 feet** continuing through said Barnhart property to an iron pin (set);
- #6- **thence along a curve to the left** having a chord bearing **N 14 54 10 W 138.29 feet**, a radius of 107.79 feet and arc length of 150.13 feet continuing through said Barnhart property to an iron pin (set);
- #7- **thence N 54 36 40 W 20.58 feet** continuing through said Barnhart property to an iron pin (set);
- #8- **thence N 33 58 50 E 14.93 feet** continuing through said Barnhart property to the place of beginning, **containing 0.07 acres.**



