Being a parcel of land located in the Northwest Quarter of the Northeast Quarter of Section No.6, Town 12, Range 12, Harrison Township, Muskingum County, Ohio and bounded and described as follows:

Commencing at an iron pin found locating the Northeast corner of the West half of the Northeast Quarter of said Section No.6, said point being North 85deg. 00min. 00sec. West 1385.80 feet from the Northeast corner of said section;

thence South 5deg. 00min. 00sec. West 407.43 feet along an existing fence line and the grantor's Easterly property line to an iron pin set for the point of beginning;

thence from this true point of beginning and continuing along said property line and an existing fence line South 5deg. 00min. 00sec. West 282.99 feet to a point in the center of Butterbean Ridge (Township Road No. 68);

thence along the center of said road North 72deg. 07min. 00sec. West 107.13 feet to a point;

thence leaving said road and along the Northeast side of a 30 foot right of way the following three courses and distances:

- 1.) North 29deg. 52min. 00sec. East 23.63 feet to a point;
- 2.) North 60deg. 08min. 00sec. West 136.28 feet to an iron pin set; and
- 3.) North 23deg. 29min. 00sec. West 152.60 feet to an iron pin set;

thence leaving said right of way North 60deg. 57min. 00sec. East 108.97 feet to an iron pin set;

thence South 80deg. 47min. 00sec. East 201.17 feet to the point of beginning and containing 1.377 acres, more or less.
