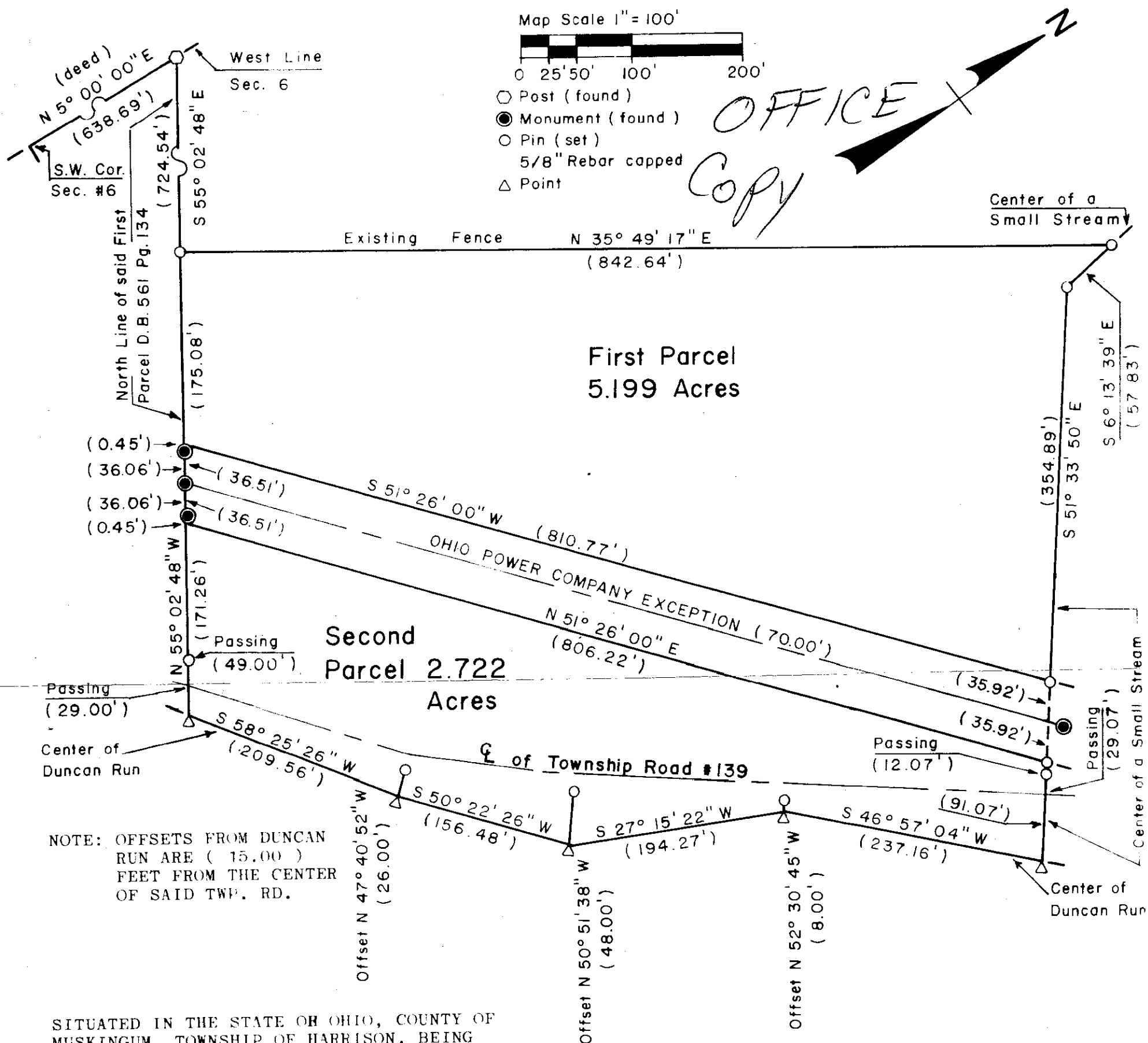

#3- S 50° 22' 26" W ( 156.48 ) feet to a point with an iron pin (set) as an offset N 47° 40' 52" W ( 26.00 ) feet;  
#4- S 58° 25' 26" W ( 209.56 ) feet; thence leaving said Duncan Run and along the North line of said First Parcel Deed Book 561, Page 134 N 55° 02' 48" W ( 171.26 ) feet to the place of beginning, passing the center of said Township Road at ( 29.00 ), an iron pin (set) at ( 49.00 ) feet, containing ( 2.722 ) acres.
