Description of Parcel 6

Situated in the State of Ohio, County of Muskingum, Township of Harrison, being in the southwest quarter of Section 21, Range 13 West, Township 11 North, of "The Congress Lands East of Scioto River", and being bounded and described as follows:

Commencing for reference at a marked stone found at the center of Section 21;

thence, with the north line of the southwest quarter of Section 21, South 89°52'52" West a distance of 590.24 feet to an iron pin set at the northwest corner of a 30.000 acres tract as conveyed to M. Tank by Deed Volume 541, Page 642 of the Muskingum County Recorder's Office;

thence, with the west line of said 30.000 acres tract, South 00°45'47" East a distance of 238.00 feet to an iron pin set, being THE TRUE POINT OF BEGINNING for this description;

thence, from said Point of Beginning continuing with the west line of said 30.000 acres tract, South 00°45'47" East a distance of 182.00 feet to an iron pin set;

thence, leaving the property line, North 89°31'07" West a distance of 1,144.77 feet to a point in the centerline of Township Road No. 484, passing through two iron pins set at distances of plus 904.77 feet and plus 1,104.77 feet, respectively;

thence, with the centerline of Township Road No. 484 (being the east line of a 5.51 acres tract as conveyed to Glenn McElhaney by Deed Volume 944, Page 96 of the Muskingum County Recorder's Office), the following two courses:

- (1) North 43°44'00" East a distance of 50.00 feet to a point;
- (2) thence North 18°24'00" East a distance of 97.68 feet to an iron pin set at the northeast corner of said 5.51 acres tract;

thence, continuing with the centerline of Township Road No. 484 (being the east line of a 5.05 acres tract as conveyed to W. Weaver by Deed Volume 528, Page 771 of the Muskingum County Recorder's Office), North 13°00'00" East a distance of 90.00 feet to an iron pin set;

thence, leaving the road, South 87°36'28" East a distance of 1,057.58 feet to the Point of Beginning, passing through two iron pins set at distances of plus 30.00 feet and plus 230.00 feet, respectively;

containing 5.000 acres, more or less.

Subject to all legal right-of-ways, easements, restrictions, reservations, and zoning regulations of record.

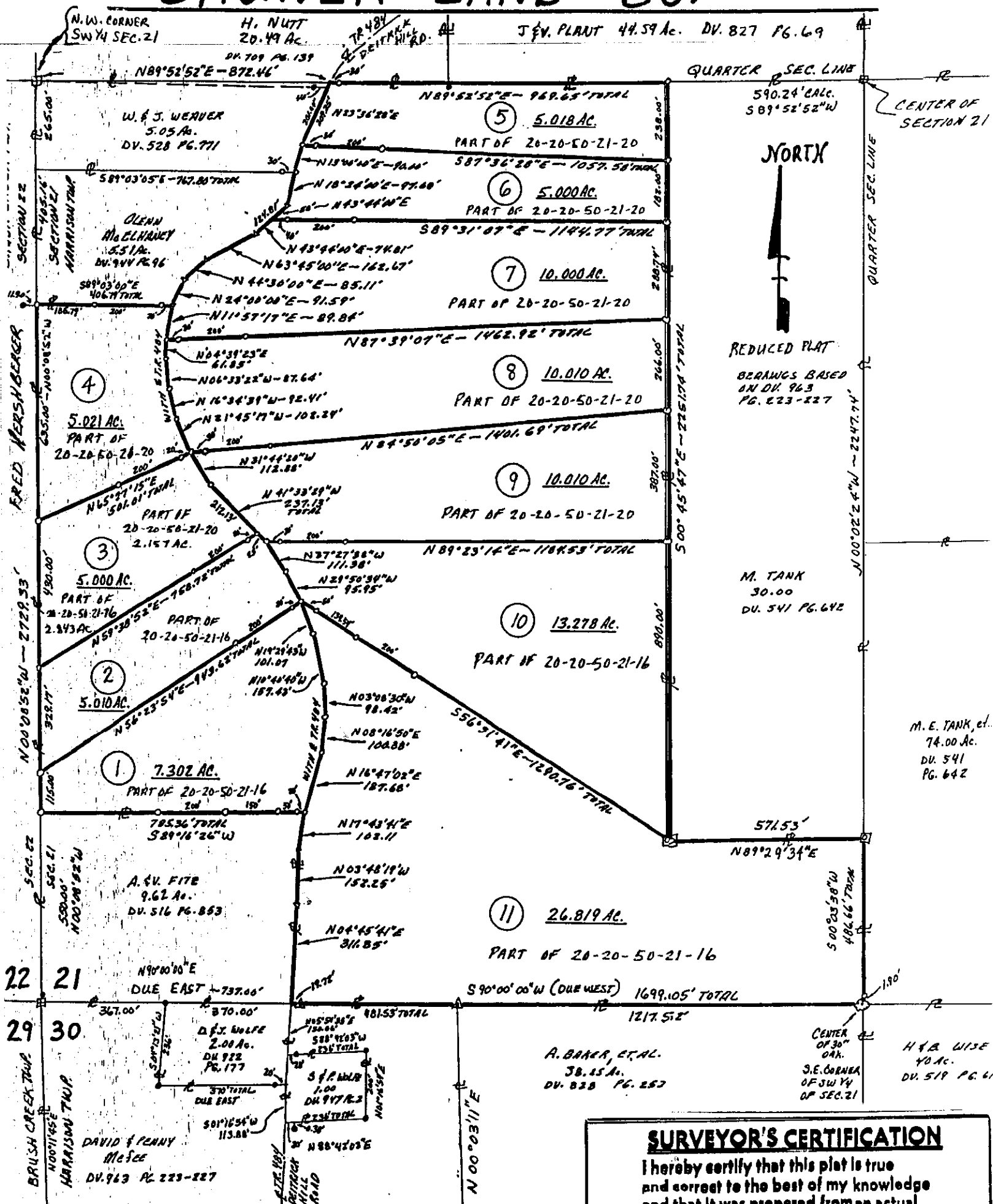
