# Description of Parcel 1

Situated in the State of Ohio, County of Muskingum, Township of Harrison, being in the southwest quarter of Section 21, Range 13 West, Township 11 North, of "The Congress Lands East of Scioto River", and being bounded and described as follows:

Commencing for reference at a marked stone found at the southwest corner of Section 21;

thence, with the west line of Section 21 (being the Township line between Harrison and Brush Creek Townships), North  $00^{\circ}08'52''$  West a distance of 550.00 feet to an iron pin set at the northwest corner of a 9.62 acres tract as conveyed to A. & V. Fitz by Deed Volume 516, Page 853 of the Muskingum County Recorder's Office, said iron pin being THE TRUE POINT OF BEGINNING for this description;

thence, from said Point of Beginning continuing with the Section line and the Township line, North  $00^{\circ}08'52''$  West a distance of 115.00 feet to an iron pin set;

thence, leaving the Township line and the Section line, North  $56^{\circ}23'54''$  East a distance of 943.62 feet to an iron pin set in the centerline of Township Road No. 484, passing through two iron pins set at distances of plus 723.62 feet and plus 923.62 feet, respectively;

thence, with the centerline of Township Road No. 484, the following five courses:

- (1) South  $19^{\circ}29'43''$  East a distance of 101.07 feet to an iron pin set;
- (2) thence South  $10^{\circ}40'40''$  East a distance of 157.43 feet to an iron pin set;
- (3) thence South  $03^{\circ}08'30''$  East a distance of 98.42 feet to an iron pin set;
- (4) thence South  $08^{\circ}16'50''$  West a distance of 100.38 feet to an iron pin set;
- (5) thence South  $16^{\circ}47'02''$  West a distance of 187.68 feet to an iron pin set at the northeast corner of the aforementioned Fitz tract;

thence, leaving the road with the north line of said Fitz tract, South  $89^{\circ}16'26''$  West a distance of 785.36 feet to the Point of Beginning, passing through four iron pins set at distances of plus 20.00 feet, plus 70.00 feet, plus 220.00 feet, and plus 420.00 feet, respectively;

containing 7.302 acres, more or less.

Subject to all legal right-of-ways, easements, restrictions, reservations, and zoning regulations of record.

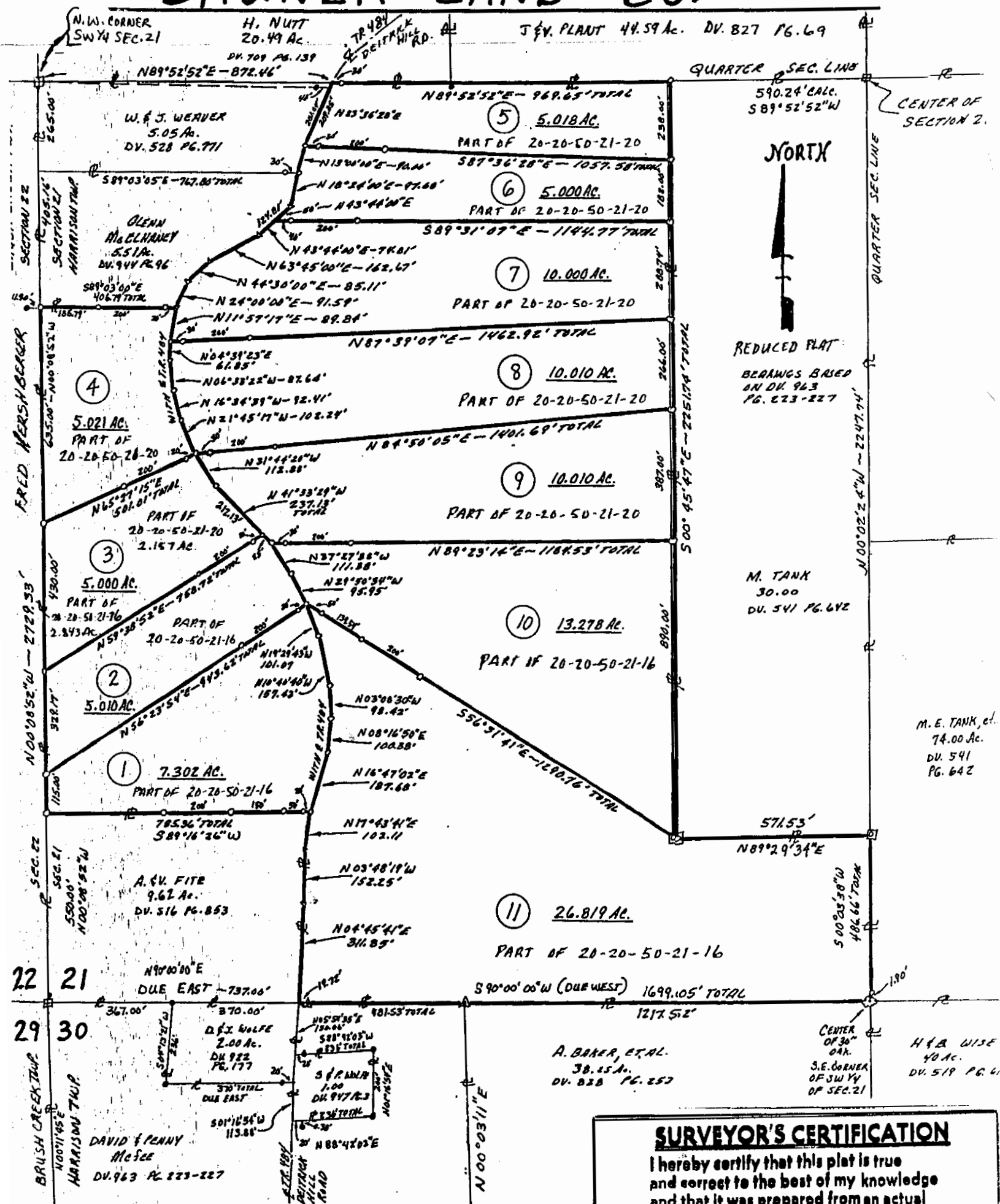
