Being a parcel of land located in the Northeast quarter of Section No. 19, and in the West half of Section No. 20, Township No. 12, Range No. 12, Harrison Township, Muskingum County, Ohio.

Beginning at the Southeast corner of the Northeast quarter of section No. 19; thence along the South line of said quarter and a fence North $84^{\circ} 42'$ West 2760' to the West line of said quarter; thence along said West line and a fence North 5° East 1600' to the center of County Road No. 66; (Note: Next five (5) courses along said County Road); thence leaving said West line North $48^{\circ} 30'$ East 465'; thence South $81^{\circ} 30'$ East 235'; thence South $65^{\circ} 30'$ East 345'; thence South 41° East 400'; thence South $39^{\circ} 15'$ East 236'; thence leaving said County Road South $48^{\circ} 45'$ West 217.8' to an iron pin (Reference: passing an iron pin at 30'); thence South $41^{\circ} 15'$ East 400' to an iron pin; thence North $48^{\circ} 45'$ East 217.8' to the center of said County Road (Reference: passing iron pins at 87' and 187'); Note: Next (3) three courses along said County Road; thence South 80° East 550; thence South $75^{\circ} 50'$ East 450'; thence South $82^{\circ} 10'$ East 255'; thence leaving said County Road South $7^{\circ} 19'$ West 110'; thence South $82^{\circ} 10'$ East 40'; thence North $7^{\circ} 19'$ East 110' to the center of said County Road; thence along said County Road South $82^{\circ} 10'$ East 80'; thence leaving said County Road South $10^{\circ} 30'$ West 347.73' ^{to an iron pin} (Reference: passing an iron pin at 16'); thence South $12^{\circ} 05'$ West 280' to an iron pin; thence South 11° West 400' to an iron pin; thence South $7^{\circ} 40'$ West 400' to an iron pin; thence South $9^{\circ} 40'$ West 200' to an iron pin in the North line of a 11.85 acre tract; thence along said North line South $78^{\circ} 45'$ West 116' to the West line of said Section No. 20; thence along said West line and a fence North $7^{\circ} 19'$ East 693.2' to the place of beginning, containing 92.62 acres in all, being 87.96 acres in section No. 19 and 4.86 acres in section No. 20.
