PARCEL;

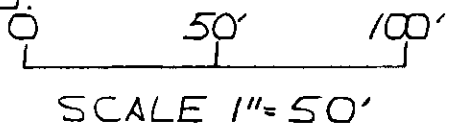

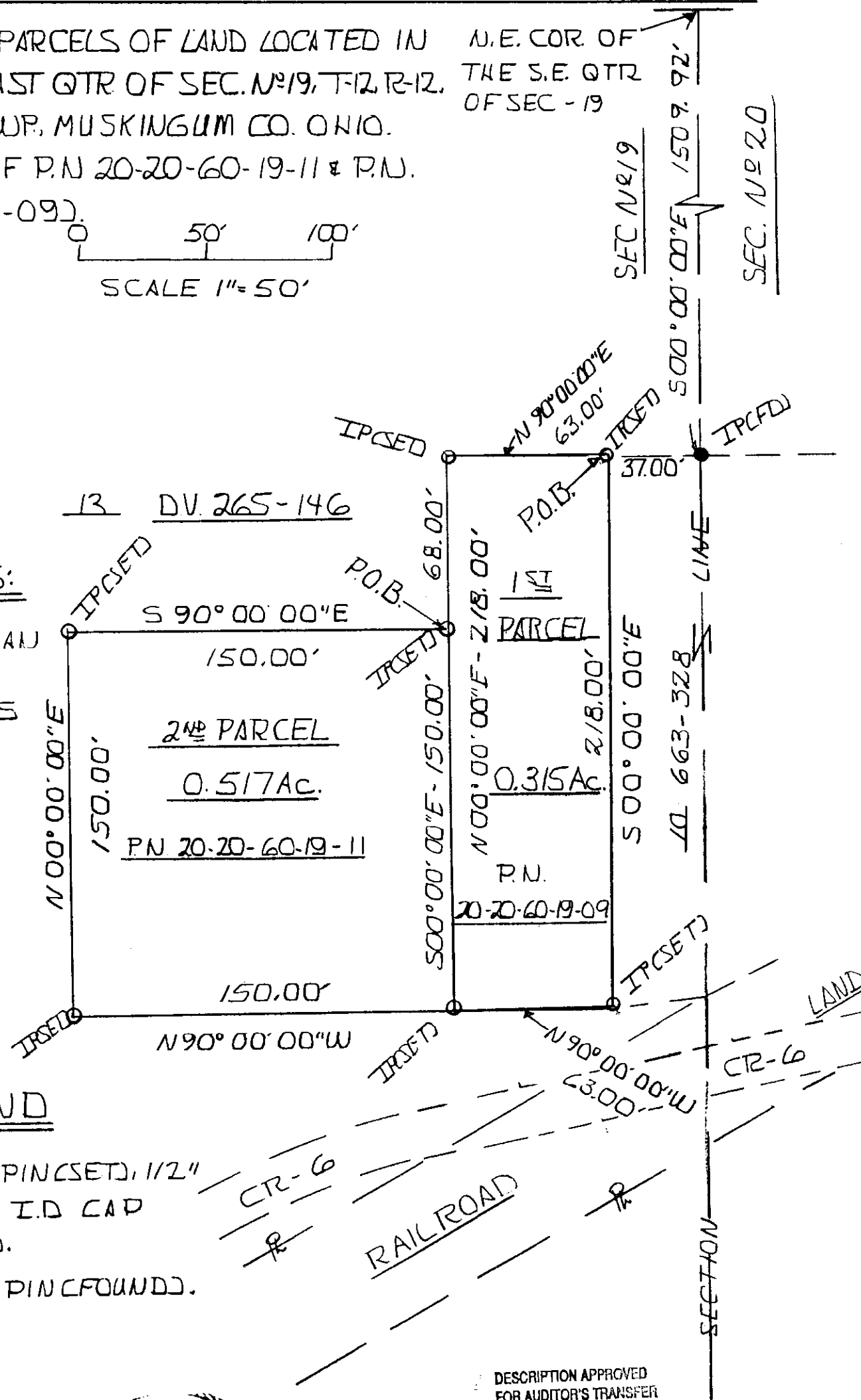
