of section South $87^{\circ} 56' 52''$ West 1363.28 feet; thence South $2^{\circ} 29' 12''$ East 522.50 feet; thence South $0^{\circ} 34' 58''$ West 510.27 feet to an
iron pin, the place of beginning; thence North $83^{\circ} 19' 26''$ East 508.80
feet to an iron pin set; thence South $0^{\circ} 34' 58''$ West 1590.28 feet
to an iron pin set; thence South $87^{\circ} 56' 52''$ West 505.25 feet to an
iron pin set; thence North $0^{\circ} 34' 58''$ East 1549.24 feet to the place
of beginning, containing 18.19 acres more or less.

Bearings are based on the North line of the Southwest Quarter of Section
19 bearing South $87^{\circ} 56' 52''$ West.

South $83^{\circ} 19' 26''$ West 35.26 feet to the place of beginning, containing
0.41 acres more or less.

Easement Two: For maintaining water wells.
Beginning at the Northwest corner of said 18.19 acre parcel of land;
thence North $0^{\circ} 34' 58''$ East 187.39 feet to an iron pin set; thence
South $72^{\circ} 22' 35''$ East 87.49 feet to an iron pin set; thence South
 $0^{\circ} 34' 58''$ West 151.10 feet to an iron pin set; thence South $83^{\circ} 19' 26''$ West 84.33 feet to the place of beginning, containing 0.33
acres more or less.


