A POINT IN A DITCH, PASSING AN IRON PIN SET AT THE NORTHWEST CORNER  
OF SAID LOT NUMBER 39 AT 133.88 FEET; THENCE NORTH 60 DEGREES 52  
MINUTES 11 SECONDS EAST 493.64 FEET TO AN IRON PINS SET, PASSING AN  
IRON PIN SET AT 7.49 FEET, 95.00 FEET, 190.00 FEET, 390.00 FEET, AND  
490.00 FEET; THENCE NORTH 46 DEGREES 54 MINUTES 48 SECONDS EAST  
327.94 FEET TO AN IRON PIN SET AT THE PLACE OF BEGINNING OF THE TRACT  
HEREIN INTENDED TO BE DESCRIBED, PASSING AN IRON PIN SET AT 227.98  
FEET; THENCE NORTH 35 DEGREES 23 MINUTES 01 SECONDS WEST 682.96 FEET  
TO A POINT IN THE CENTER OF COUNTY ROAD NUMBER 6, PASSING AN IRON PIN  
SET AT 652.96 FEET; THENCE WITH THE CENTER OF SAID ROAD THE NEXT FOUR

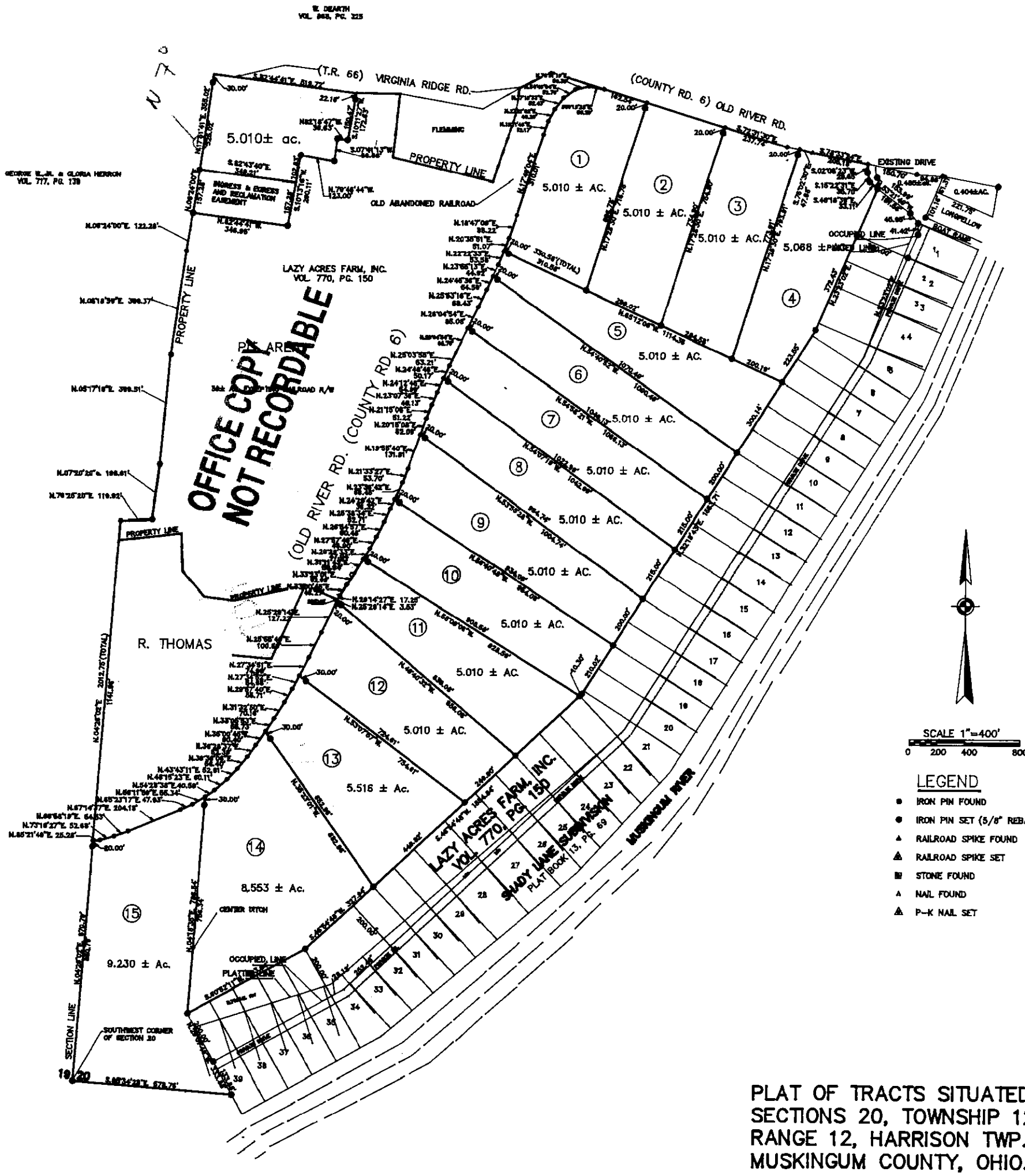
