Situated in the Township of Highland, County of Muskingum, State of Ohio and being 39.838 acres in the northwest quarter of section 10 of township 2 range 5 of the United States Military District and being more particularly described as follows,

BEGINNING at a 1/2 inch capped rebar found at the southeast corner of the northwest quarter of said section 10 thence with the south line of said quarter and with the lands of Robert W. and Crystal B. Beach as recorded in official records volume 1159 page 366 and with the lands of the Colman Family Partnership LTD as recorded in official records volume 2083 page 406 N 87° 40' 52" W a distance of 658.71 feet to an iron pin set thence leaving said quarter line and with the lands of John and Mary Morrow as recorded in official records volume 1691 page 713 N 02° 14' 39" E a distance of 2633.89 feet to a point on the north line of said northwest quarter in Stoney Point road having passed through an iron pin set at 2620.89 feet thence with said quarter line and with the lands of Darren Lee and Tracie L. Mallett as recorded in official records volume 1756 page 217 and the lands of John and Michelle Bush as recorded in official records volume 1725 page 894 and the lands of Timothy Allan Flesher Sr. as recorded in official records volume 1157 page 761 S 87° 46' 42" E a distance of 658.71 feet to a point in Stoney Point road thence leaving said road and with the lands of Daniel L. and Melodie R. Jarrell as recorded in official records volume 1898 page 584 S 02° 14' 39" W a distance of 1140.83 feet to a 5/8 inch capped rebar found having passed through a 5/8 inch capped rebar found at 30.00 feet thence with the lands of Christopher J. and Michelle A. Welsh as recorded in official records volume 1514 page 903 S 02° 14' 39" W a distance of 1494.18 feet to the **BEGINNING** and containing 39.838 acres and being all of the property conveyed in official records volume 1563 page 40 and being all of auditors parcel# 23-60-10-11-000.


