A. SARCHET PROPERTY

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF HIGHLAND, AND BEING PART OF THE NORTHEAST QUARTER OF SECTION 12, TOWNSHIP 2, RANGE 5, AND BEING ALL THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 563, PAGE 812. FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT A STONE FOUND AT THE SOUTHWEST CORNER OF LOT #1 OF THE VILLAGE OF BLOOMFIELD, AS RECORDED IN PLAT BOOK 1, PAGE 113, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, SOUTH 82 DEGREES - 40 MINUTES - 40 SECONDS EAST, 50.07 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 21 DEGREES - 00 MINUTES - 08 SECONDS WEST, 116.29 FEET TO AN IRON PIN SET; THENCE, SOUTH 84 DEGREES - 57 MINUTES - 26 SECONDS EAST, 122.69 FEET TO AN IRON PIN SET; THENCE, SOUTH 16 DEGREES - 50 MINUTES - 09 SECONDS WEST, 115.50 FEET TO A POST; THENCE, NORTH 84 DEGREES - 59 MINUTES - 26 SECONDS WEST, 206.07 FEET ALONG THE NORTH LINE OF LANDS RECORDED IN DEED VOLUME 983, PAGE 360 TO AN IRON PIN SET; THENCE, NORTH 84 DEGREES - 30 MINUTES - 00 SECONDS WEST, 15.00 FEET TO A POINT IN THE CENTER OF LOWER BLOOMFIELD ROAD; THENCE, ALONG THE CENTERLINE THEREOF, THE FOLLOWING SIX (6) COURSES AND DISTANCES:

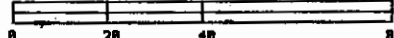

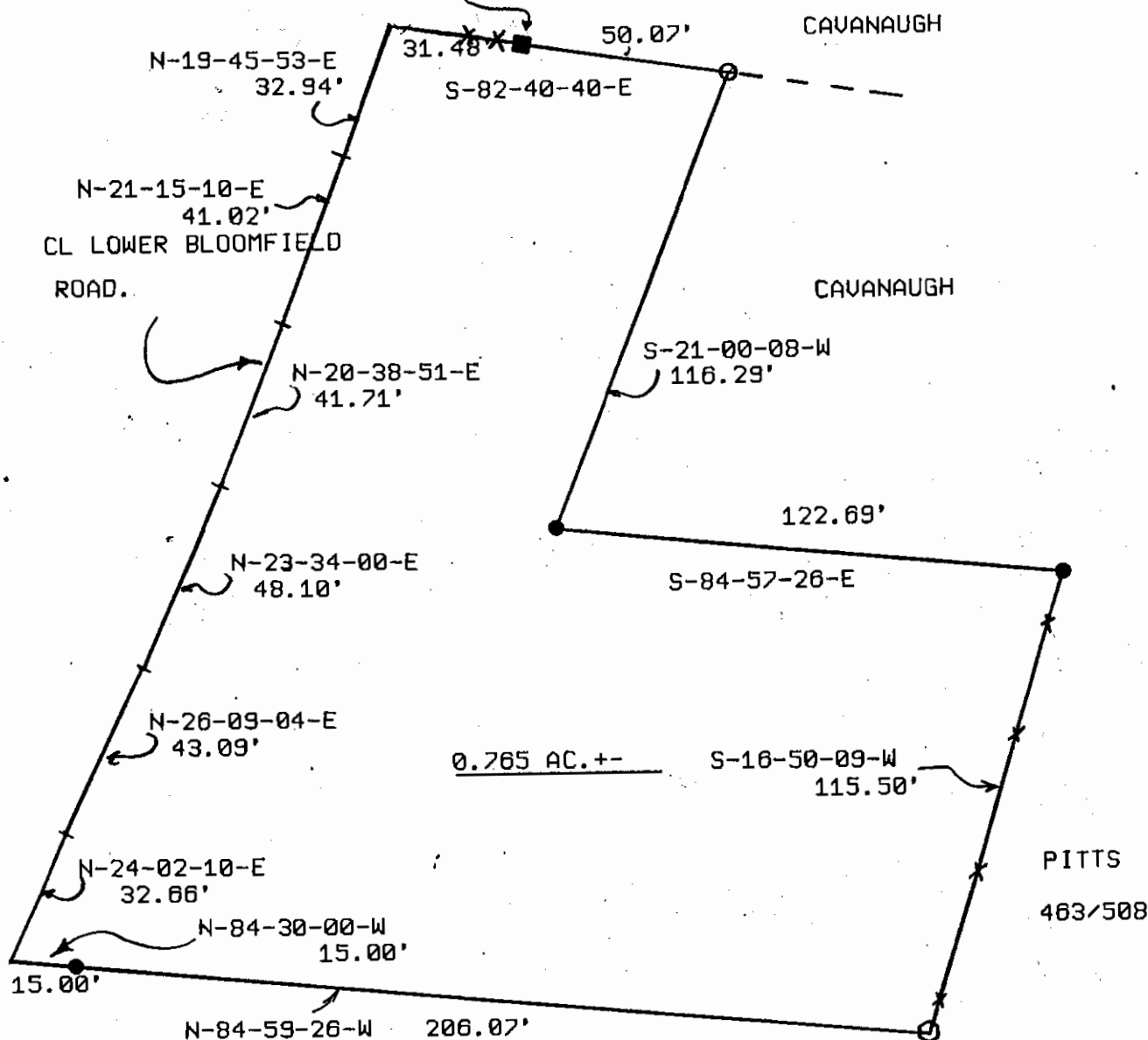
