5830 FRIENDSHIP DR

Situated in the State of Ohio, County of Muskingum,
Township of ~~Highland~~, being part of the East half of the
Southeast Quarter of Section #9, Township #2, Range #5 of
the United States Military District and being more
particularly described as follows:

Commencing at an iron pin (found) in concrete at the
Southeast corner of said Section #9; thence along the South
line of said Section #9 N 87° 57' 00" W (522.03) feet to
a stone (found) at the Southwest corner of Lot #1 as recorded
in the plat, of the Village of Bloomfield Replat Book 1, Page
113; thence continuing along said South line of Section #9
N 87° 57' 00" W (50 00) feet to an iron pin (set) on the
West line of Lower Bloomfield Road County Rd. #65 (formerly)
the Concord Road, said iron pin being the place of beginning
for the property herein intended to be described; thence
continuing along the South line of said Section #9 N 87° 57' 00" W
(212.52) feet to an iron pin (set) on the South side of State
Route #83 (Friendship Drive); thence leaving the South line
of said Section #9 and along the South side of said State
Route #83 N 67° 51' 42" E (254.76) feet to an iron pin
(set) on the West line of said County Road #65; thence
leaving the South side of said State Route #83 and along
the West line of said County Road #65 S 12° 49' 44" W
(106.26) feet to the place of beginning containing (0.255)
acres.

The bearings within this description are based on the
South line of said Section #9 as described in the prior deed
reference Deed Book 804, Page 107 being N 87° 57' W.

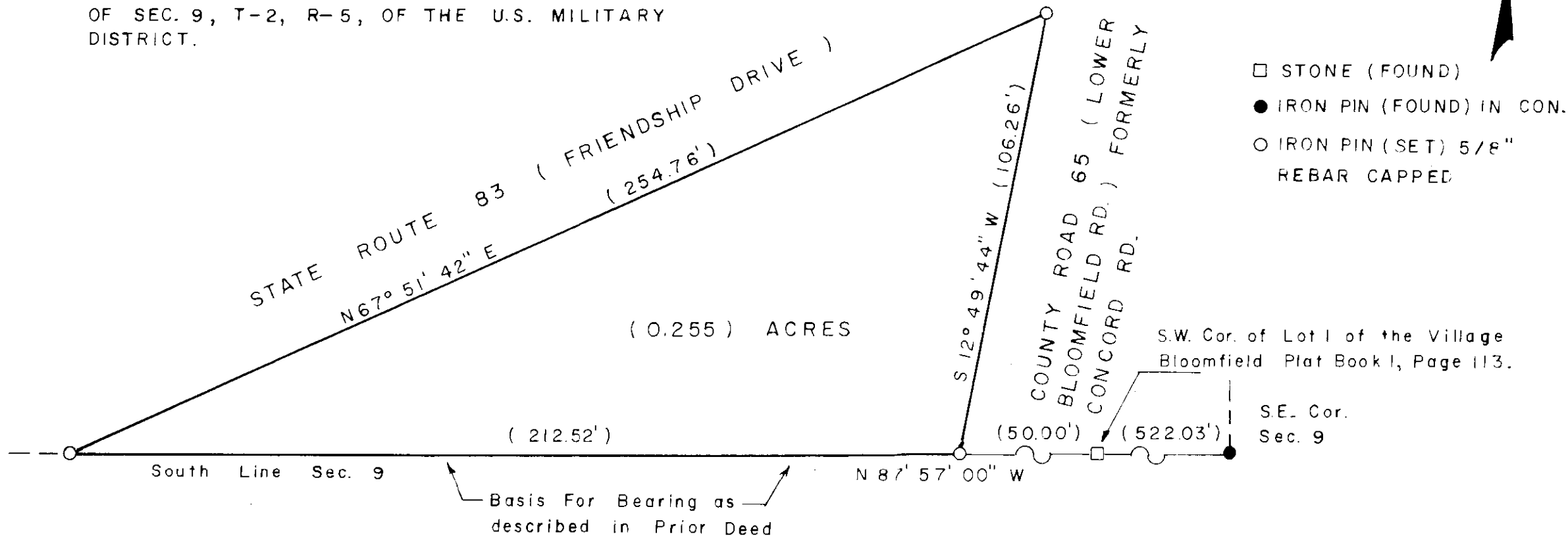
