Beginning at an iron pipe marking the Mid-Point of Section 19, said iron pipe being the Place of Beginning of the herein described tract.

Thence S 01 degrees 23 minutes 05 seconds E 1009.12 feet, along the west line of the aforementioned James property, to an iron pin set.

Thence N 65 degrees 15 minutes 33 seconds E 1430.38 feet to an iron pin set.

Thence N 01 degrees 12 minutes 02 seconds W 431.24 feet, along the east line of the aforementioned James property, to a capped iron pin found marking the Northwest corner of the L. and M. Hanna property (DB 1152 Pg. 894).

Thence N 01 degrees 47 minutes 33 seconds W 653.25 feet, along the east line of the aforementioned James property, to an iron pipe found.

Thence S 89 degrees 27 minutes 06 seconds W 1302.98 feet, along the north line of the aforementioned James property, to an iron pipe found, said iron pipe being the Southwest corner of the J. P. and C. A. Arena property (DB 829 Pg. 133).

Thence S 00 degrees 46 minutes 20 seconds E 661.48 feet, along the west line of the aforementioned James property, to the Place of Beginning, containing 41.4671 acres, 19.7493 acres in the Northeast Quarter of Section 19, and 21.7178 acres in the Southeast Quarter of Section 19.

Subject to all legal and existing right of ways, easements, leases, conditions and regulations of record. All iron pins set are 5/8" x 30" rebar with an identification cap. The bearings are based on the west line of the L. and M. Hanna property (DB 1152, Pg. 894) as surveyed by W. J. Biedenbach in Dec., 1998.


