

DEED DESCRIPTION
FOR
KEITH VICKERS
TRACT #3

Situated in Highland Township, Muskingum County, Ohio, and being a part of the southwest quarter of Section #21, Township #2 north, Range #5 west, and being more particularly described as follows:

Commencing at a stone found at the northeast corner of the southwest quarter of Section #21, thence on the east line of the southwest quarter of Section #21, S 00° 00' 04" E, a distance of 193.47 feet to an iron pin set, the BEGINNING, thence on the east line of the southwest quarter of Section #21, S 00° 00' 04" E, a distance of 304.53 feet to an iron pin found, on the west edge of a private road, thence on the west edge of said private road the next two (2) calls:

1. S 14° 23' 05" W, a distance of 137.52 feet to an iron pin found.
2. S 04° 58' 38" E, a distance of 208.00 feet to a point in the center of County Rd. #65, (having passed through an iron pin found at 168.25 feet), thence with the center of County Rd. #65 the next two (2) calls:

1. N 38° 28' 38" W, a distance of 365.70 feet to a point.
2. N 44° 20' 36" W, a distance of 12.86 feet to a point, thence N 35° 51' 51" E, a distance of 431.22 feet to the beginning, (having passed through an iron pin set at 42.33 feet), and containing 1.748 acres more or less, and being a part of the property conveyed in volume 577, page 88 of the deed records of Muskingum County, Ohio, to Keith Vickers.

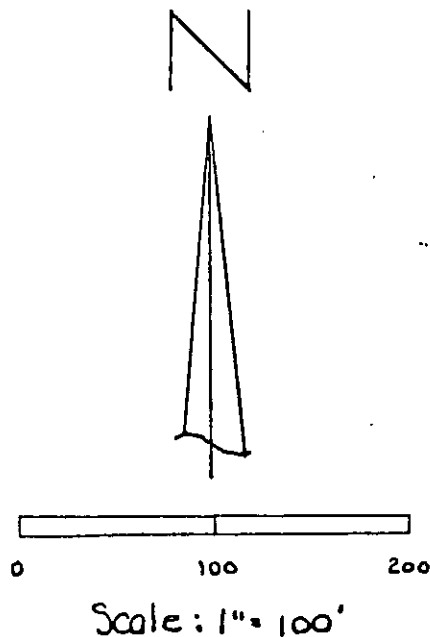
Subject to all easements or leases of public record.

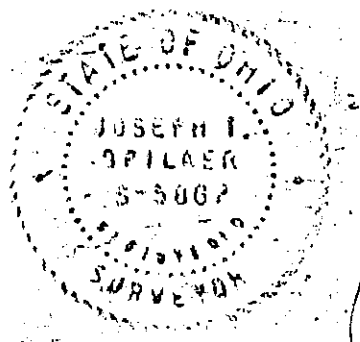
