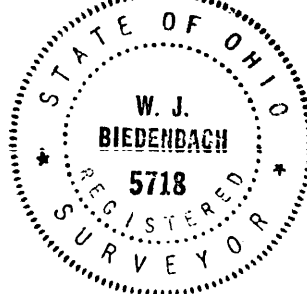

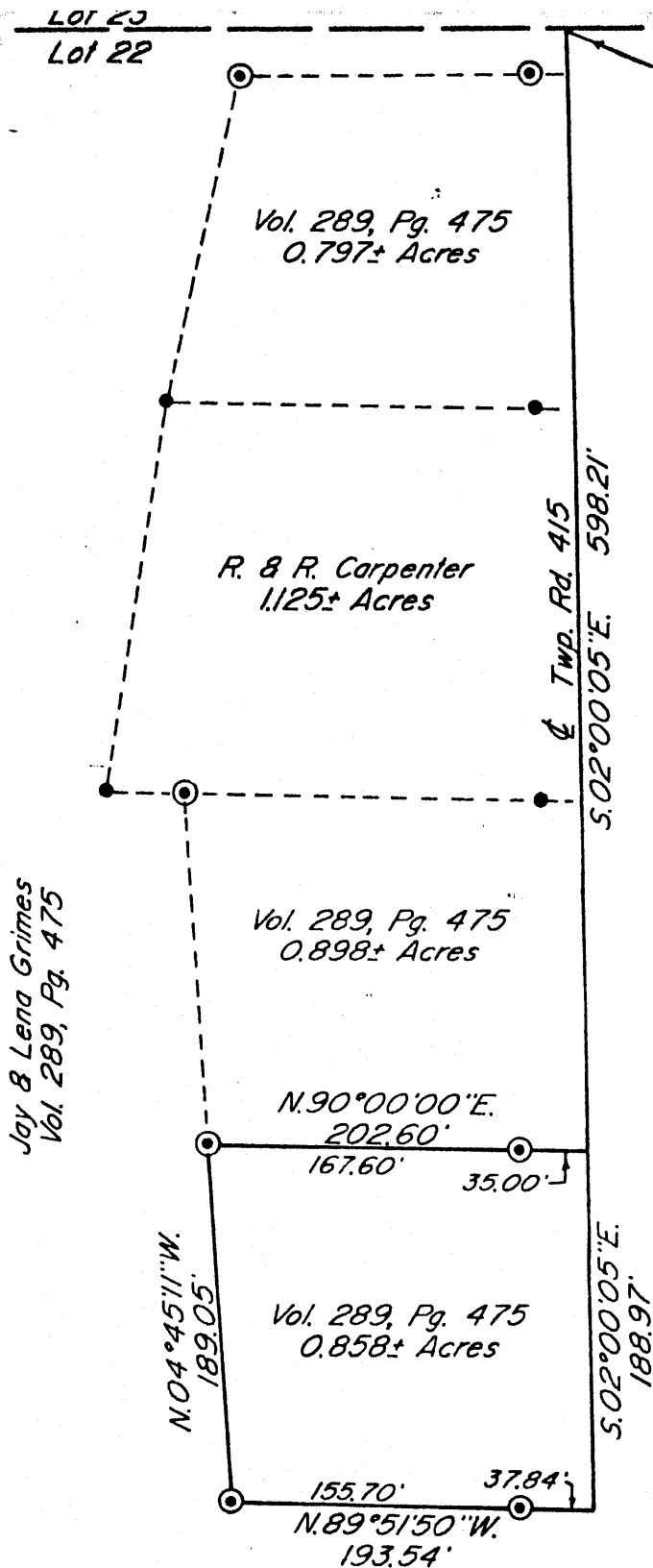

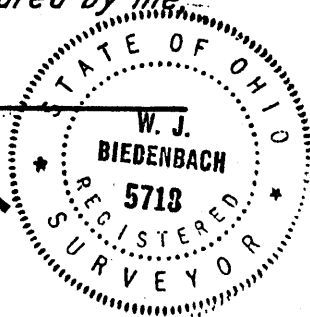


Bearings are based on the previous survey of 1.125± Acres as surveyed by W. J. Biedenbach, registered surveyor #5718 and dated May 17, 1979.

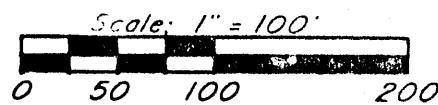
