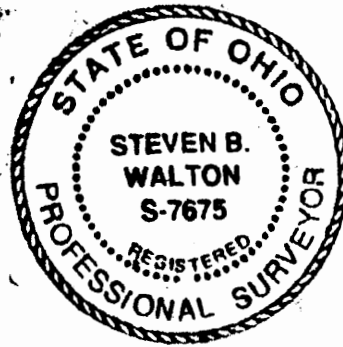
Description for Dean Smith

Being a part of the Southeast quarter of section 13 and the Northwest quarter of section 18, quarter township 1, township 1 North Range 9 West, Hopewell township Muskingum county Ohio, and being a tract of land last transferred to the First National Bank trustees as recorded in deed book 561 page 30 of the Muskingum county records and being more particularly described as follows.

Beginning for reference at a stone found at the Southwest corner of lot 25, quarter township 1, township 1 North, range 9, West, said stone being the place of beginning for the tract herein described, Thence South 88 degrees 04 minutes 46 seconds East 1376.33 feet along the south line of a tract of land deeded to Oxford oil company as recorded in deed book 846 page 240, to a stone found, Thence South 02 degrees 30 minutes 33 seconds West 519.75 feet to a stone found on the West line of said oxford oil tract, Thence continuing along said tract South 02 degrees 31 minutes 40 seconds West 1938.22 feet to a point on the East side of pleasant Valley road, Passing an iron pipe found at 1799.86 feet, Thence North 88 degrees 01 minutes 22 seconds west 1397.42 feet to a stone found, passing an iron pipe found at 41.05 feet, Thence North 03 degrees 00 minutes 58 seconds East 2456.90 feet to the place of beginning containing 78.2356 acres more or less with 73.0616 acres lying in section 13 and 5.174 acres lying in section 18. Subject to all easements either written or implied. 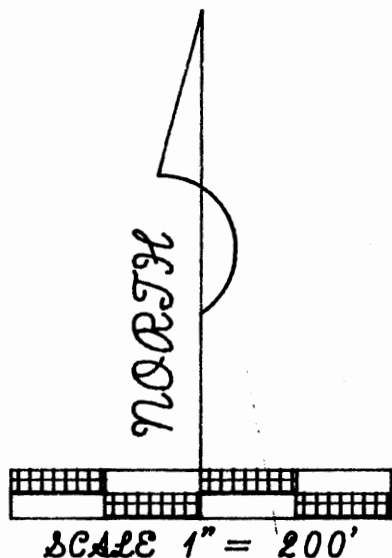
