Commencing at an iron pin at the Northwest Corner of the Northeast Quarter of Section 14; Thence North 90°00'00" East on Section line 1418.38 feet to an iron pin found; Thence leaving Section line South 00°03'45" East 76.72 feet to an iron pin set the place of beginning; Thence South 00°03'45" East along G. Thompson Vol. 974, Page 261, 155.00 feet to an iron pin found; Thence continuing along G. Thompson South 58°22'24" West 146.01 feet to Macedonia Road passing an iron pin found at 116.60 feet; Thence in Macedonia Road and along Derone Vol. 761, Page 251 North 31°55'57" West 255.02 feet to a point; Thence leaving Macedonia Road and along the split lines of Dean Filkill Vol. 850, Page 120, the next three courses and distances: North 73°33'44" East 116.40 feet to a point passing an iron pin set at 23.73 feet, North 88°37'25" East 90.85 feet to a point, and South 70°33'02" East 60.00 feet to the place of beginning containing 0.99 acres more or less:

Bearings are based on the North line of the Northeast Quarter of Section 14 bearing North 90°00'00" East.

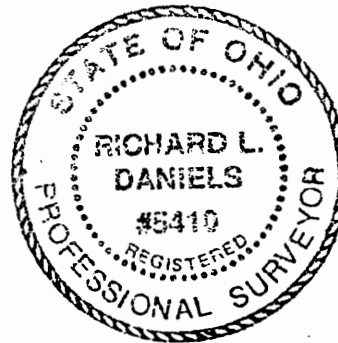

Iron pins set are No. 5 reinf. bars 30 inches long with plastic ID caps.

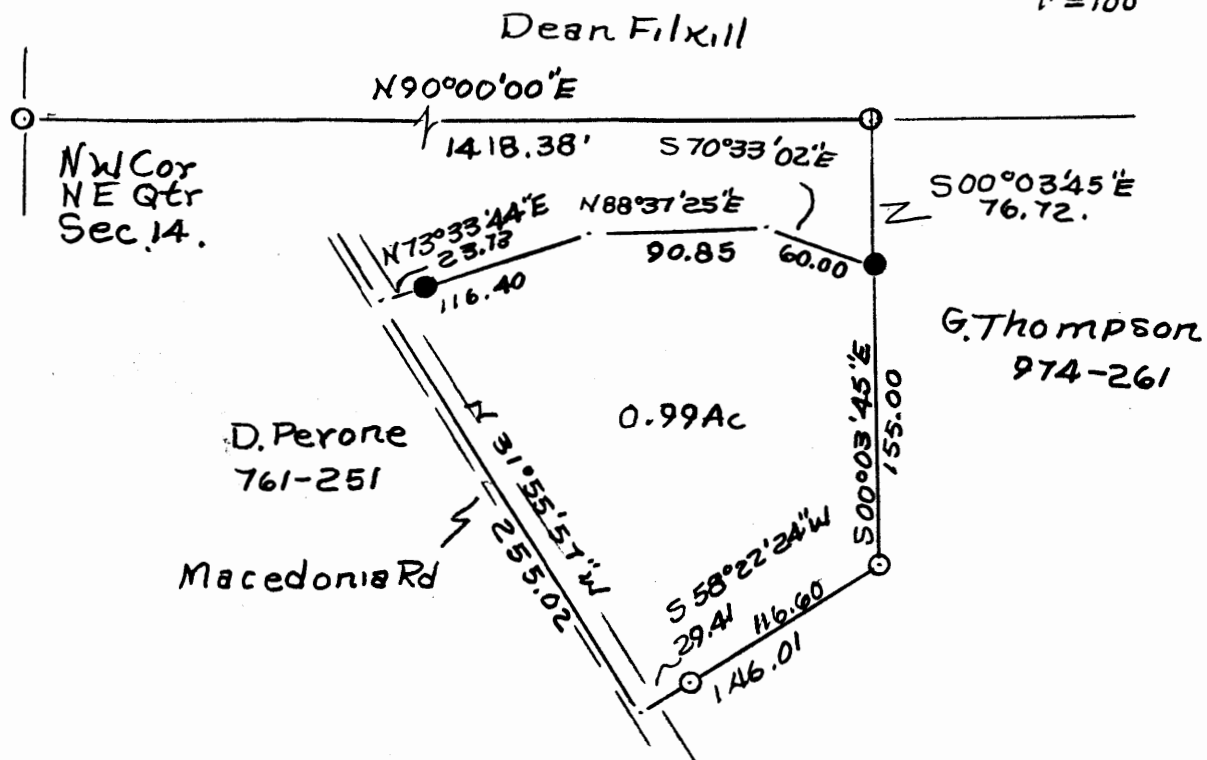

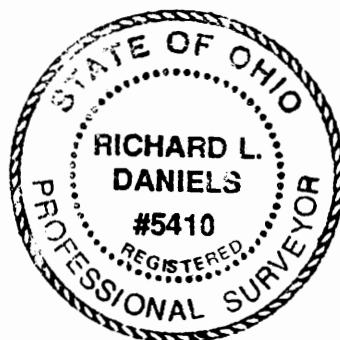
