PARCEL ONE:


Situated in the State of Ohio, County of Muskingum, Township of Hopewell.

DACW 69-82-D-0012 in 1985 and 1986 the following eleven (11) courses and dis-
tances south 22 degrees 05 minutes 27 seconds east 110.85 feet to an iron pin;
thence south 16 degrees 31 minutes 34 seconds east 259.39 feet to an iron pin;
thence south 19 degrees 22 minutes 23 seconds east 256.91 feet to an iron pin;
thence south 18 degrees 30 minutes 27 seconds east 260.13 feet to an iron pin;
thence south 57 degrees 07 minutes 25 seconds east 190.24 feet to an iron pin;
thence south 56 degrees 17 minutes 28 seconds east 229.44 feet to an iron pin;

feet to a stone found; thence north 18 degrees 28 minutes 38 seconds west 451.62
feet to an iron pin found; thence north 20 degrees 39 minutes 54 seconds west
332.64 feet to an iron pin; thence north 54 degrees 14 minutes 27 seconds east
297 feet to an iron pin; thence north 38 degrees 33 minutes 31 seconds east
270.21 feet to an iron pin found; thence north 85 degrees 05 minutes 14 seconds
east 228.04 feet to an iron pin found on the aforesaid fee line; thence along
said fee line south 63 degrees 21 minutes 11 seconds east 304.80 feet to an iron
pin found; thence continuing along said fee line south 22 degrees 05 minutes 27
seconds east 140.84 feet to the true place of beginning, containing thirty-six
and forty hundredths (36.40) acres more or less, being 2.10 acres in Lot 16,
0.81 acres in Lot 17, 20.31 acres in Lot 24 and 13.18 acres in Lot 25.
