Situated in the State of Ohio, County of Muskingum, Township of Hopewell, Northwest Quarter, of Section #20, of Township #1, Range #9, of the US Military District:

Being part of the Sixth Parcel as described in prior deed reference Volume 882, Page 312, also being part of Muskingum County Auditor's Parcel Number 25-25-35-20-02-000, and more particularly described as follows;

- Beginning at a wood post (found by previous survey) marking the Northeast corner of said Northwest Quarter of Section #20; thence along the East line of said Northwest Quarter of Section #20 S 03 22 26 W 447.06 feet to an iron pin (found) at the place of beginning for the property herein intended to be described;
- #1- thence continuing along the East line of said Northwest Quarter S 03 22 26 W 204.34 feet to an iron pin (set);
  - #2- thence through said Sixth Parcel N 48 02 30 W 862.91 feet to the center of Murrey Drive as recorded in Plat Book 16, Page 100, passing an iron pin (set) on the East right-of-way line for said Murrey Drive at 837.89 feet;
  - #3- thence along the center of said Murrey Drive N 44 21 09 E 150.00 feet to a point on the line between Sections #20 and #11, from which an iron pin (set by previous survey) on said line for reference bears S 86 37 30 E 33.11;
  - #4- thence along the South line of the property described in deed reference Volume 1014, Page 346 S 35 35 13 E 436.25 feet to an iron pin (set by previous survey);
  - #5- thence continuing along the South line of said Volume 1014, Page 346 S 66 57 52 E 320.54 feet to the place of beginning containing 2.000 acres.






Center Line of Murrey Drive, recorded in Plat Book #16, Page #100.
