Thence along the centerline of said road, North 86 degrees 01 minutes 16 seconds West, 218.18 feet to a point;

Thence through the lands presently owned by Verba Bear, (OR 2093-752), North 08 degrees 07 minutes 32 seconds West, 369.01 feet to an axle found, on the southwest corner of lands presently owned by Henry E. Knaup,(OR 3055-436), passing a concrete monument found disturbed at 138.14 feet;

Thence along the south line of said Knaup lands, and the south lines of lands presently owned by Thomas A. and Peggy A. Passwater, (DR 1026-119) and Jody A. and Jeffrey S. Hedges, (OR 3243-278, and OR 2602-762), North 85 degrees 21 minutes 58 seconds East, 296.46 feet to an axle found, on the west line of Mt. Sterling, (DR "K", Page 726), passing an iron pipe found at 65.82 feet, and being perpendicular and south of the line 0.19 feet, and passing an iron pipe found at 230.50 feet;

Thence along the west line of said Mt. Sterling, South 03 degrees 38 minutes 00 seconds West, 86.43 feet to the principal place of beginning, containing 2.27 acres, more or less, and being part of Auditor's Parcel Number 25-40-41-62-000, (+- 0.66 acres in R\W of US Rte. 40).
