LEGAL DESCRIPTION for the Lucile Porter trust

Commencing at an iron pin found at the southeast corner of Lot 14 and the southwest corner of Lot 1 of the United States Military Lands, thence, north 85 degrees – 22 minutes – 28 seconds west, 840.18 feet to a point; thence, north 04 degrees – 46 minutes – 40 seconds east, 524.19 feet to an iron pin found, and the *true point of beginning* for the parcel herein intended to be described;

Thence, continuing north 04 degrees – 46 minutes – 40 seconds east, 569.26 feet along the east line of those lands now or formerly owned by John & Lois Yaw, as recorded in Deed Volume 684, page 231 to an iron pin set on the south right-of-way of State Route 40;

Thence, continuing north 04 degrees – 46 minutes – 40 seconds east, 74.97 feet to a point in the centerline of said State Route 40;

Thence, along the centerline thereof, south 84 degrees - 11 minutes - 02 seconds east, 732.46 feet to a point;

Thence, along the west line of those lands now or formerly owned by Matthew D. & Karen L. Epifano, as recorded in Deed Volume 1902, page 683, the following two (2) courses and distances:

- 1. south 05 degrees 49 minutes 02 seconds west, 97.28 feet to an iron pin found on the south right-of-way of said State Route 40;
- 2. south 00 degrees 02 minutes 53 seconds east, 163.82 feet to an iron pin found;

Thence, south 80 degrees – 48 minutes – 05 seconds east, 140.00 feet along the south line of aforesaid Epifano lands to an iron pin found;

Thence, south 09 degrees – 42 minutes – 37 seconds west, 283.31 feet along the west line of those lands now or formerly owned by John H. Mayo & Glenna J. Rhinebarger, as recorded in Deed Volume 1598, page 145 to an iron pin found;

Thence, north 77 degrees – 21 minutes – 49 seconds west, 271.50 feet along the north line of those lands now or formerly owned by Linda Porter, as recorded in Deed Volume 1119, page 589 to an iron pin found;

Thence, south 19 degrees – 14 minutes – 11 seconds west, 195.50 feet along the west line of aforesaid Porter lands to an iron pin found;

Thence, north 77 degrees – 21 minutes – 50 seconds west, 546.95 feet along the north line of those lands now or formerly owned by Commercial Electronics, as recorded in Deed Volume 1148, page 606 and the northerly line of those lands now or formerly owned by Linda Porter, as recorded in Deed Volume 1525, page 186, to the *point of beginning*, and *containing 11.737 acres more or less* of which 11.306 acres lies in Lot 14 and 0.431 acres lies in Lot 1.
