COMMENCING AT THE NORTHWEST CORNER OF LOT #47 OF THE VILLAGE OF GRATIOT AS RECORDED IN DEED VOLUME K, PAGE 342; THENCE, ALONG THE SOUTH LINE OF THE OLD NATIONAL ROAD, SOUTH 77 DEGREES - 02 MINUTES - 20 SECONDS WEST, 51.42 FEET TO A POINT AT THE NORTHEAST CORNER OF THOSE LANDS DESCRIBED IN PARCEL NO. 1 OF AFORESAID DEED VOLUME 1043, PAGE 137; THENCE, SOUTH 12 DEGREES - 35 MINUTES - 08 SECONDS EAST, 132.00 FEET TO A POINT AT THE SOUTHEAST CORNER THEREOF, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING SOUTH 12 DEGREES - 35 MINUTES - 08 SECONDS EAST, 79.94 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 81 DEGREES - 02 MINUTES - 09 SECONDS WEST, 82.95 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 86 DEGREES - 07 MINUTES - 48 SECONDS WEST, 90.99 FEET TO AN IRON PIN FOUND AT THE SOUTHEAST CORNER OF THOSE LANDS RECORDED IN DEED VOLUME 957, PAGE 186; THENCE, NORTH 10 DEGREES - 09 MINUTES - 00 SECONDS WEST, 60.00 FEET TO A POINT, FROM WHICH AN IRON PIN BEARS NORTH 10 DEGREES - 09 MINUTES - 00 SECONDS WEST, 132.00 FEET; THENCE, NORTH 77 DEGREES - 05 MINUTES - 29 SECONDS EAST, 170.18 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.283 ACRES MORE OR LESS.

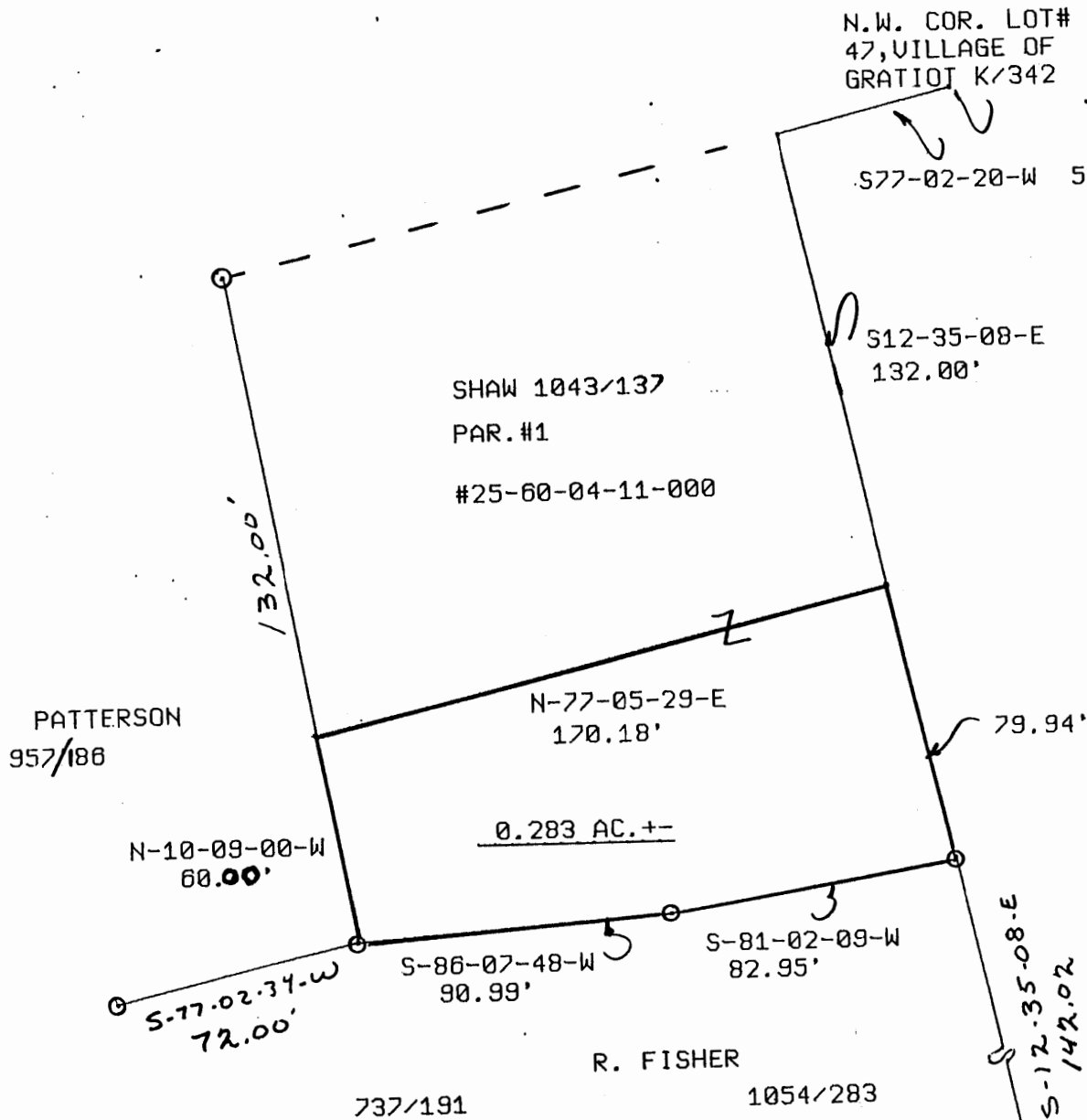
