Commencing for reference at the Southeast corner of Section 6,, Township 18N, Range 15W, Hopewell Township, Thence, N 04° 33' 15" E with the East line of Section 6, 616.86 feet to an iron pin found, Thence, N 83° 58' 36" W 2285.34 feet to a Corner Post found marking the Northeast corner of said parcel conveyed to Guest, the same being the Northwest corner of a parcel being currently conveyed to Millard R. and Virginia R. Osborn (Trustees), of record by Official Record 1559, Page 398, and being along the South line of a 1.314 acre parcel also being conveyed to Millard R. and Virginia R. Osborn (Trustees), of record by Official Record 1559, Page 396, the **PRINCIPLE PLACE OF BEGINNING**, of the **2.285 Acre** parcel herein to be described;


