LEGAL DESCRIPTION FOR H. HURST

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF HOPEWELL, AND BEING PART OF THE NORTHWEST QUARTER OF SECTION 6, QUARTER TOWNSHIP 2, TOWNSHIP 18, RANGE 15, AND BEING PART OF THOSE LANDS DESCRIBED IN DEED VOLUME 991, PAGE 118; FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHWEST CORNER OF SAID SECTION 6, THENCE, SOUTH 04 DEGREES - 50 MINUTES - 00 SECONDS WEST, 1172.10 FEET TO A POINT IN THE CENTERLINE OF TOWNSHIP ROAD # 29 (OLD NATIONAL ROAD); THENCE, ALONG THE CENTERLINE THEREOF, THE FOLLOWING FOUR (4) COURSES AND DISTANCES:

- 1) NORTH 77 DEGREES 00 MINUTES 00 SECONDS EAST, 76.36 FEET TO A POINT;
- 2) NORTH 76 DEGREES 54 MINUTES 10 SECONDS EAST, 896.52 FEET TO A POINT;
- 3) NORTH 76 DEGREES 54 MINUTES 10 SECONDS EAST, 228.74 FEET TO A POINT;
- 4) NORTH 77 DEGREES 02 MINUTES 20 SECONDS EAST, 141.24 FEET TO THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED;

THENCE, CONTINUING ALONG SAID ROAD, NORTH 77 DEGREES - 02 MINUTES - 20 SECONDS EAST, 169.81 FEET TO A POINT AT THE INTERSECTION OF AFORESAID TOWNSHIP ROAD, AND THE CENTERLINE OF AN ACCESS ROAD TO STATE ROUTE 440, AND FROM WHICH POINT AN IRON PIN BEARS SOUTH 27 DEGREES - 27 MINUTES - 06 SECONDS WEST, 71.48 FEET; THENCE, SOUTH O6 DEGREES - 34 MINUTES - 24 SECONDS EAST, 349.49 FEET ALONG THE CENTERLINE OF SAID ACCESS ROAD TO A POINT IN THE CENTERLINE OF US ROUTE 40 AT STATION 743+81.6, FROM WHICH AN IRON PIN FOUND BEARS NORTH 35 DEGREES - 09 MINUTES - 38 SECONDS WEST, 83.58 FEET; THENCE, SOUTH 83 DEGREES - 26 MINUTES - 00 SECONDS WEST, 153.76 FEET TO A POINT IN THE CENTERLINE OF SAID U.S. ROUTE, AT THE CENTERLINE OF AN UNNAMED STREAM; THENCE, NORTH 02 DEGREES - 39 MINUTES - 47 SECONDS WEST, 189.57 FEET TO A POINT IN THE CENTER OF SAID STREAM; THENCE, NORTH 17 DEGREES - 44 MINUTES - 17 SECONDS WEST, 144.18 FEET ALONG SAID STREAM TO THE POINT OF BEGINNING, AND CONTAINING 1.179 ACRES MORE OR LESS.
