DESCRIPTION OF PARCEL # 25 - 65 - 05 - 02 and # 25 - 65 - 05 - 03 , WHICH WAS CONVEYED TO DAMON P. AND ZENITH KENNISON IN VOLUME 1095 , PAGE 350 OF MUSKINGUM COUNTY RECORDS.

Situate in the State of Ohio, County of Muskingum, Township of Hopewell, and being part of Section # 5 in Township 5 North , Range 15 West of the Congress Lands East of the Scioto River and being parcel # 25 - 65 - 05 - 02 and #25 - 65 - 05 - 03 as conveyed to Damon P. And Zenith Kennison in Deed Volume 1095, Page 350, of the Muskingum County Deed Records, and being more particularly bounded and described as follows:

Beginning for reference at a Right of Way monument found on the Muskingum County line at the intersection of said county line and the south right of way line of U.S. #40 at centerline station 775+78.59 , 70.00 feet right , thence along the county line and the North line of Section # 5 North 86 degrees 12 minutes 18 seconds West 265.84 feet to an iron pin set on the west line of Creamery Street extended toward U.S. #40 and the true place of beginning for the parcel to be described ; thence leaving said county line South 13 degrees 26 minutes 08 seconds East 43.63 feet to a point in the centerline of U.S.#40 at station 773+33 ; thence along said centerline South 68 degrees 35 minutes 30 seconds West 103.53 feet to a point in said centerline at station 772+29.47 and the line dividing said Kennison parcels; thence continuing along said centerline South 68 degrees 35 minutes 30 seconds West 121.50 feet to a point at station 771+07.97 and the east line of Karl Jones (Vol.326 Pg. 330) ; thence leaving said centerline on the line between Karl Jones (Vol.326 Pg.330) and Damon P. And Zenith Kennison North 13 degrees 07 minutes 30 seconds West 143.72 feet to an iron pin set on the Muskingum County line and the north line of Section # 5 ; thence along said county line South 86 degrees 12 minutes 18 seconds East 232.50 feet to an iron pin set on the west line of Creamery Street , passing an iron pin set on the line dividing said Kennison parcels at 125.67 feet .

Containing 0.478 Acres, more or less , subject to all easements , restrictions , or right of ways , either written or implied. All iron pins set are 30 inch long by 5/8 inch diameter rebar with a yellow cap labeled "BINCKLEY S-7879". (NOTE : 0.337 Acres ,more or less , lies in U.S. # 40 Right of Way)

Bearings contained herein are assumed on the Centerline of U.S. #40 as being South 68 degrees 35 minutes 30 seconds West and are for angular measurement only.

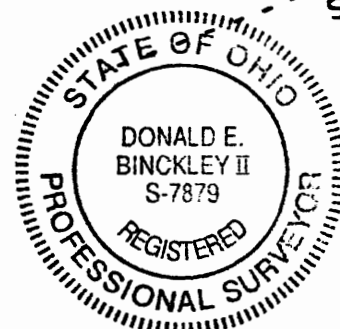

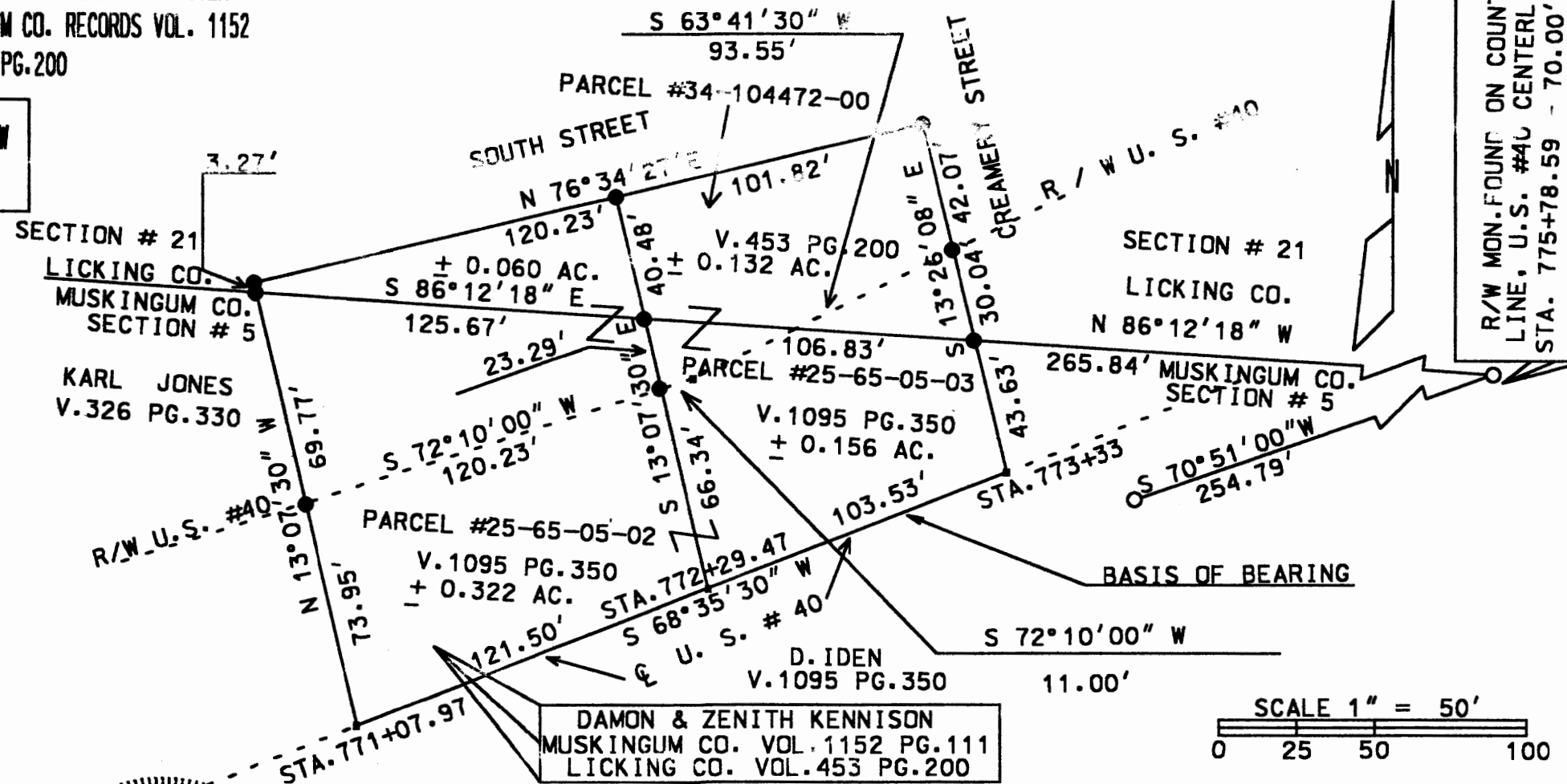
