Situated in the State of Ohio, County of Muskingum, Township of Hopewell, bounded and described as follows:

Being a part of the Northwest and Northeast Quarters of Section 7, Township 18, Range 15, of the Congress Lands East of the Scioto River, also being part of the lands now owned by Steven J. Hildebrand as recorded in Muskingum County Official Record 1734, Page 941 and being more particularly described as follows:

Beginning at an iron pin found on the Northwest corner of Section 7 of Hopewell Township; thence along the north line of said Section 7 and the south line of lands now owned by Norval H. Harkness (DR 1120-134), South 89 degrees 16 minutes 23 seconds East 2425.73 feet to an iron pin found on the northwest corner of lands now owned by James J. Hammond and Linda White Strout (OR 1870-295);

thence along said Hammond and Strout's west line South 01 degrees 07 minutes 46 seconds East 354.36 feet to an iron pin found on the north line of lands now owned by Brian and Tracy Hill (OR 1797-721 and 1797-723);

thence along said Hills' north line South 89 degrees 09 minutes 48 seconds West 214.48 feet to an iron pin found on said Hills' northwest corner;

thence along the said Hills' west line the following five courses:

- 1) South 02 degrees 48 minutes 57 seconds West 134.96 feet to an iron pin found;
- 2) North 87 degrees 42 minutes 24 seconds East 108.38 feet to an iron pin found;
- 3) South 00 degrees 05 minutes 06 seconds East 139.63 feet to an iron pin found;
- 4) South 70 degrees 04 minutes 22 seconds East 127.13 feet to an iron pin found;
- 5) South 88 degrees 15 minutes 53 seconds East 183.90 feet to a point on the centerline of Mt. Perry Road (CR-30), passing an iron pin found at 160.34 feet;

thence along said centerline of Mt. Perry Road the following two courses:

- 1) South 03 degrees 16 minutes 26 seconds East 112.99 feet to a point;
- 2) South 05 degrees 12 minutes 19 seconds East 331.54 feet to a point; thence through lands now owned by Steven J. Hildebrand (OR 1734-941) the following three courses:
- 1) South 71 degrees 17 minutes 01 seconds West 1253.07 feet to an iron pin set, passing an iron pin set at 30.00 feet;
- 2) North 52 degrees 02 minutes 47 seconds West 830.79 feet to an iron pin set;
- 3) South 78 degrees 33 minutes 22 seconds West 828.58 feet to an iron pin set on the east line of lands now owned by Lawrence Wright (OR 163-344), said line being the Muskingum/Licking County line;

thence along said line North 00 degrees 16 minutes 32 seconds West 1205.71 feet to the place of beginning,

containing 71.50 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.

Bearings are based on a previous survey by Steven B. Walton, Reg. No. 7675 and are for angular calculations only.

Iron pins set are 5/8 inch diameter by 30 inch long rebar capped with a plastic identification cap.
