DESCRIPTION FOR CONVEYANCE

BEING A PART OF THE SOUTHWEST QUARTER OF SECTION 17, TOWNSHIP 18, RANGE 15, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, HOPEWELL TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN SET AT THE SOUTHWEST CORNER OF THE SOUTHWEST QUARTER OF SECTION 17; THENCE ALONG THE WEST LINE OF SAID SECTION NORTH 00 DEGREES 23 MINUTES 57 SECONDS WEST 436.58 FEET TO AN IRON PIN SET; THENCE LEAVING SAID WEST LINE NORTH 71 DEGREES 15 MINUTES 28 SECONDS EAST 516.87 FEET TO AN IRON PIN SET; THENCE SOUTH 36 DEGREES 05 MINUTES 55 SECONDS EAST 223.80 FEET TO THE CENTER LINE OF TOWNSHIP ROAD NUMBER 30 (BAIRD ROAD), PASSING AN IRON PIN SET AT 198.80 FEET; THENCE ALONG SAID CENTERLINE SOUTH 53 DEGREES 54 MINUTES 05 SECONDS WEST 215.24 FEET TO A POINT IN SAID CENTERLINE; THENCE LEAVING SAID CENTERLINE SOUTH 26 DEGREES 37 MINUTES 21 SECONDS EAST 343.67 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF SECTION 17, PASSING AN IRON PIN SET AT 14 FEET; THENCE ALONG SAID SOUTH LINE OF SECTION 17 NORTH 88 DEGREES 49 MINUTES 45 SECONDS WEST 598.50 FEET TO THE PLACE OF BEGINNING.

CONTAINING 6.527 MORE OR LESS ACRES, SUBJECT TO LEGAL ROAD RIGHT-OF-WAY OF TOWNSHIP ROAD NUMBER 30 (BAIRD ROAD), AND ALL APPLICABLE EASEMENTS.

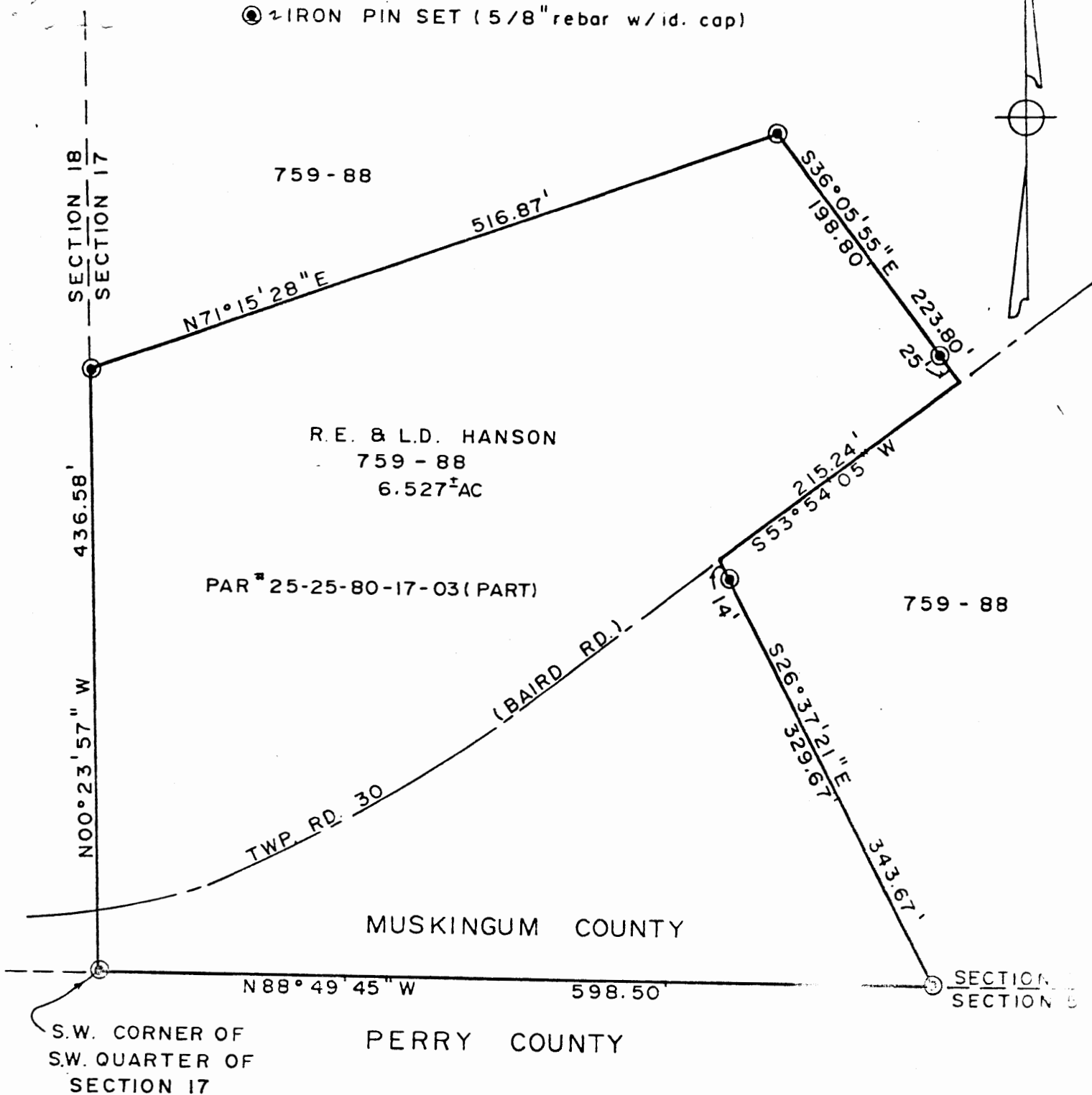

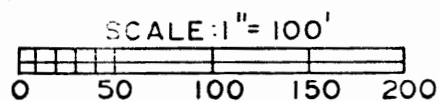
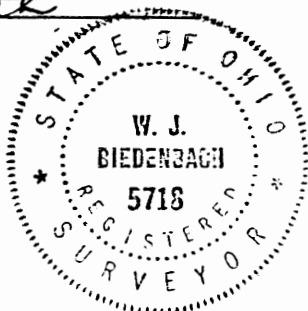
