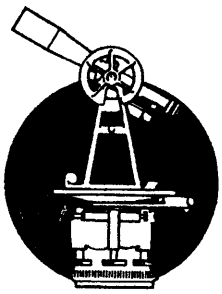

Stevens and Pauline R. Stevens; thence along the east line of said 1.52 acre parcel north 0 degrees 26 minutes 52 seconds west 316.30 feet to an iron pin at the northeast corner of said 1.52 acre parcel; thence along the north line of said 1.52 acre parcel south 89 degrees 32 minutes 31 seconds west 250.01 feet to a point in the center of Gorsky Road at the northwest corner of said 1.52 acre parcel; thence along the center of Gorsky Road north 27 degrees 58 minutes 18 seconds west 56.37 feet to a point at the southwest corner of a 1.22 acre parcel conveyed to Mathew J.
