DESCRIPTION OF PART OF PARCEL # 25 -85 -11-02-001 WHICH WAS
CONVEYED TO FRANCES H. (DAVIS) MCGUIRK IN VOLUME 1072, PAGE 280 OF MUSKINGUM
RECORDS.

Situate in the State of Ohio, County of Muskingum, Township of Hopewell, and being part of the
Northeast Quarter of Section #11, Township #18 North, Range #15 West and being part of parcel #25 -
85 -11-02 -001 as conveyed to Frances H. (Davis) McGuirk in O.R. Volume 1072, Page 280, of the
Muskingum County Deed Records, and being more particularly bounded and described as follows:

Beginning for reference at the Southeast corner of the Northeast Quarter of Section #11 at a stone found,
thence North 82 degrees 03 minutes 18 seconds West 175.50 feet to a iron pin found at the corner of
Tom Saunders property (passing an axle at 94.84 feet); Thence North 07 degrees 30 minutes 00 seconds
East 143.59 feet to an iron pin found at a fence corner ; Thence along said fence North 76 degrees 34
minutes 38 seconds West 1447.24 feet to a p.k. nail set in the centerline of County Road # 123 (Morgan
Road) and the True place of beginning , Thence leaving said true place of beginning North 25 degrees 44
minutes 51 seconds East 118.89 feet to a p.k. nail set in the centerline of said road ; thence South 65
degrees 09 minutes 14 seconds East 209.70 feet to an iron pin set (passing an iron pin set at 15.32 feet) ;
thence South 30 degrees 32 minutes 34 seconds West 78.07 feet to an iron pin set ; thence North 76
degrees 34 minutes 38 seconds West 207.94 feet the True place of beginning (passing an iron pin found
at 190.13 feet).

Containing 0.464 Acres, more or less, subject to all easements , restrictions , or right of ways , either
written or implied, and a 40 foot right of way of County Road #123 (Morgan Road) . All iron pins set are
30 inch long by 5/8 inch diameter rebar with a yellow cap labeled "BINCKLEY S-7879".

iron pin set ;thence South 77 degrees 31 minutes 47 seconds East 72.37 feet to an iron pin set ; thence
South 60 degrees 27 minutes 25 seconds East 75.00 feet to an iron pin set thence South 01 degrees
01 minutes 40" West 50.00 feet to an iron pin set ; thence north 79 degrees 23 minutes 00 seconds West
99.81 feet to an iron pin set thence North 63 degrees 19 minutes 07 seconds West 28.11 feet to an iron pin
and the place of beginning.

Bearings contained herein are assumed on the south line of Parcel # 25 -85 -11 -02 as being North 81
degrees 07 minutes 02 seconds West as established by a survey completed in October , 1992 by Stephen
Bowman and are for angular measurement only.

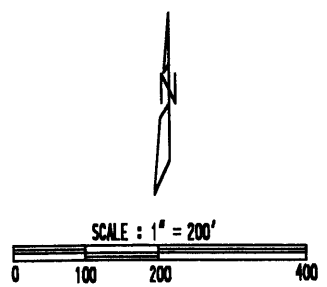

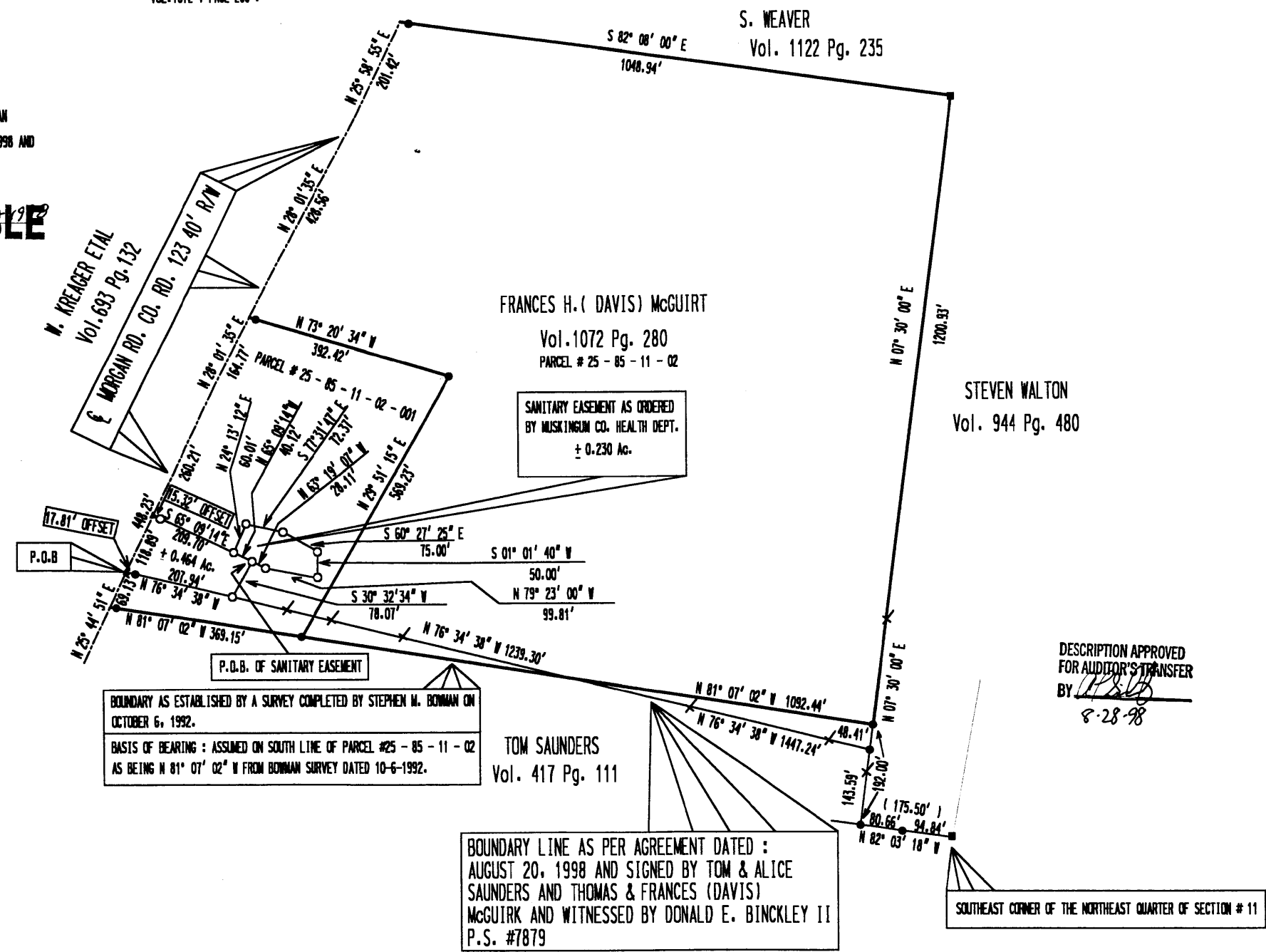
