SURVEY DESCRIPTION

Danny Riley
Parcel 1

PART OF AUDITORS PARCEL
25-85-14-06-000 (8.08 Acres)

Situated in the Northeast quarter of section 14, T-18, R-15, Hopewell Township, Muskingum County, Ohio. Being part of the lands of Danny Riley conveyed in Deed book 1892 page 875 of the Muskingum County Deed records, and being described as follows:

Beginning at the Southwest corner of the Northeast quarter of section 14;

Thence, **N.01°18'22"E.** a distance of **543.50 feet** along the West line of said quarter section to a point on the Southwest corner of the lands, now or formerly, owned by D. & L. Hill (1086/027), said point is located, **S.01°18'22"W.** a distance of 2,118.93 feet from a stone found marking the Northwest corner of the Northeast quarter of Section 14;

Thence, **N.89°41'53"E.** a distance of **581.62 feet** along the South line of said Hill lands to a set rebar, passing a found iron pin at 42.77';

Thence, **S.20°51'37"E.** a distance of **157.78 feet** through the lands of D. Riley (1892/875) to set rebar;

Thence, **S.01°24'31"E.** a distance of **409.23 feet** through said Riley lands to a point on the South line of the Northeast Quarter of section 14, located 8' south of the centerline of Wesley Chapel Road, passing a set rebar at 370.91';

Thence, **N.89°07'18"W.** a distance of **660.33 feet** along said Quarter section line and along said road to the point of beginning.

The above described parcel contains 8.08 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

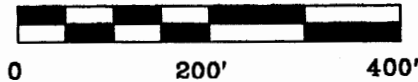

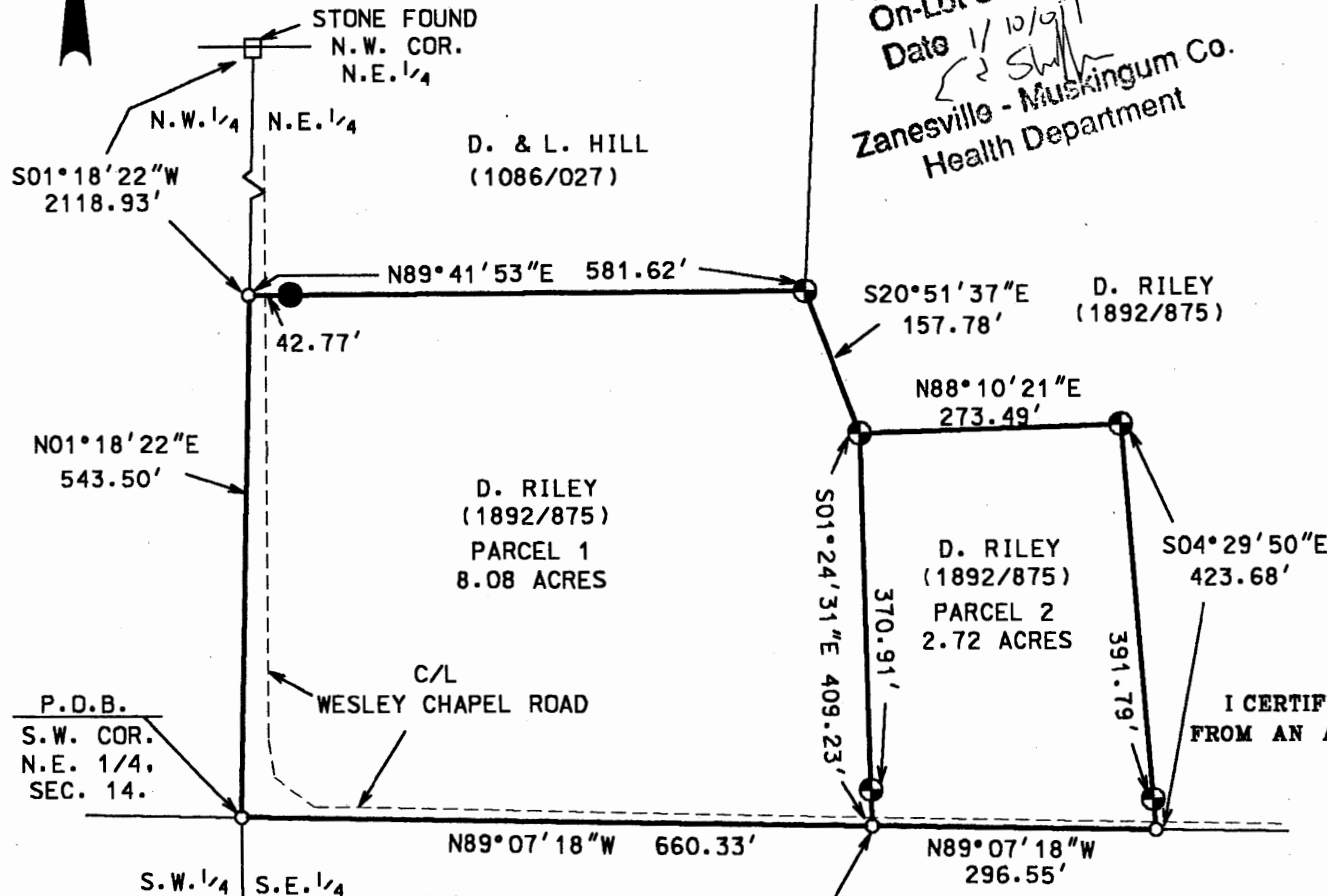
