Situated in the State of Ohio, County of Muskingum, Township of Hopewell, Southwest Quarter of Section 14, T18N, R15W and Township of Newton, Northwest Quarter of Section 2, T17N, R15W, being all of the lands now owned by Paul C. Haueisen as recorder in OR 2566-805 of the Muskingum County Recorder's Office and more fully described as follows.

Beginning for reference at a pipe found at the southwest corner of said Section 14, Hopewell Township, thence with the common line of said Hopewell/Newton Townships, S 86°04'51" E a distance of 1342.83 feet to an iron pin found (biedenbach) at a common corner of the lands now owned by Brian D. Hill (DR 1125-690) and said Haueisen, the principal place of beginning;

thence with the common line if said Hill/Haueisen's lands the following thirteen (13) courses:

1. S 86°04'51" E a distance of 133.34 feet to a point in the center of a ravine, passing an iron pin found (biedenbach) at 102.34 feet, 2.85 feet south of line;
2. N 03°15'00" W a distance of 119.15 feet to a point in the center of a ravine, a reference pin found (biedenbach) bearing S 54°02'12" W a distance of 42.23 feet;
3. N 27°49'14" E a distance of 97.51 feet to a point in the center of a ravine, a reference pin found (biedenbach) bearing N 64°10'12" W a distance of 13.21 feet;
4. N 55°44'06" E a distance of 41.02 feet to a point in the center of a ravine;
5. N 27°57'46" E a distance of 44.32 feet to a point in the center of a ravine;
6. N 40°25'44" E a distance of 48.31 feet to a point in the center of a ravine;
7. N 33°35'24" E a distance of 138.91 feet to a point in the center of a ravine;
8. N 58°50'43" E a distance of 51.62 feet to an iron pin set in the center of a ravine;
9. N 29°34'02" E a distance of 47.09 feet to a point in the center of a ravine;
10. N 30°30'18" E a distance of 59.04 feet to a point in the center of a ravine;
11. N 33°25'05" E a distance of 28.12 feet to a point in the center of a ravine;
12. N 22°34'33" E a distance of 85.99 feet to a point in the center of a ravine;
13. N 37°12'11" E a distance of 87.80 feet to a point in the center of Ford Road (T-412), passing an iron pin set at 74.02 feet;

thence with the center of said Ford Road the following six (6) courses:

1. with a curve turning to the right an arc length of 88.29 feet, a radius of 156.31 feet, with a chord bearing of S 40°06'00" E and a chord length of 87.12 feet to a point;
2. S 26°26'21" E a distance of 146.93 feet to a point;
3. with a curve turning to the left an arc length of 170.55 feet, a radius of 199.68 feet, with a chord bearing of S 50°07'31" E and a chord length of 165.41 feet to a point;
4. S 83°54'56" E a distance of 77.54 feet to a point;
5. S 87°19'04" E a distance of 281.38 feet to a point;
6. with a curve turning to the right an arc length of 95.67 feet, a radius of 513.73 feet, with a chord bearing of S 79°08'17" E and a chord length of 95.53 feet to a point at the northwest corner of the lands now owned by Rose Lee Dinges & Mark Dinges (OR 1802-359);

thence with the common line of said Dinges/Haueisen's lands the following three (3) courses:

1. S 03°56'52" W a distance of 442.03 feet to an iron pin set on the Township line, passing an iron pin set at 19.23 feet;
2. N 86°04'51" W a distance of 191.50 feet to an iron pin set;
3. S 03°47'03" W a distance of 1302.43 feet to a point in the center of Kent Run, passing an iron pin set at 1208.80 feet;

thence with the center of said Kent Run the following thirteen courses:

1. N 61°52'23" W a distance of 52.74 feet to a point;
2. N 75°26'06" W a distance of 75.85 feet to a point;
3. N 81°51'52" W a distance of 91.69 feet to a point;
4. N 82°45'52" W a distance of 132.69 feet to a point;
5. N 85°38'11" W a distance of 118.58 feet to a point;
6. N 82°09'16" W a distance of 195.66 feet to a point;
