

**Description of centerline of 50 foot easement  
For Brian D. Hill running from Coopermill Road  
Southerly to 91.577 acre parcel across property  
Owned by Wesley A. Rambo ( OR 2087,Pg. 483 )  
On Parcel No. 25-85-15-02-000 in the N.E. Qtr.  
Sec. 15, Twp. 18, Range 15 Hopewell Twp.  
Muskingum County, Ohio**

Situated in the State of Ohio, County of Muskingum, Township of Hopewell:

Being in the Northeast Quarter of Section 15, Township 18, Range 15 in said Township and on Property owned by Wesley A. Rambo, Trustee Official Record Book 2087, Page 483, Parcel No. **25-85-15-02-000** , the center of said 50 easement described as follows and being **25.00** feet on each side of the following courses and distances:

**Commencing** at a point in Coopermill Road at the northwest corner of said northeast quarter of section 15 , said point bears **N3°48'59"E 30.83** feet from an iron pin found; thence **S 85°41'34"E** on the north line of said quarter **479.81** feet to a point in coopermill road at **The True Place of Beginning** for the following center of said easement; thence through said property of Wesley A. Rambo, Trustee the following 18 courses and distances:

- 18 - S 37°47'02"W 116.92** feet to a nail set on the north line of said 91.577 acre parcel at the **End of said Easement**, said nail bears **S 76°23'58"E 295.99** feet from an iron pin set on the west line of said northeast quarter of section 15 at the northwest corner of said 91.577 acre parcel and being **25.00** feet each side of the above described centerline containing **1.514** more or less acres in said easement.
