PART OF AUDITORS PARCEL  
25-85-15-05-000 (0.590 Acres)

Situated in the Northwest Quarter of Section 15, T-18, R-15, Hopewell Township, Muskingum County, Ohio. Being part of the lands of Abundant Life Ministries, Inc., last conveyed in Deed Book 1658 page 780 of the Muskingum County Deed Records and being described as follows:

**Beginning** at the Northwest corner of Section 15, reference by a found iron pin bearing, S.72°54'11"E. a distance of 18.53;


Thence, **N.83°46'28"E.** a distance of **160.41** feet along the North line of section 15, located in the road right of way of Asbury Chapel Road;

Thence, **S.04°27'46"E.** a distance of **160.25** feet through the lands of the Abundant Life Ministries (1658/780) to a set rebar, passing a set rebar at 10.07 feet;

Thence, **S.83°38'50"W.** a distance of **160.21** feet through said Ministries Lands to a point in the center of Hopewell Road, passing a set rebar at 130.11 feet;

Thence, **N.04°32'26"W.** a distance of **160.60** feet along the center of said Road to the point of beginning.

The above described parcel contains 0.590 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. 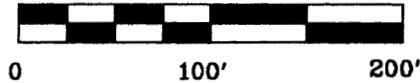
SITUATED IN THE NORTHWEST QUARTER OF SECTION 15, T-18, R-15,
