ALL OF AUDITORS PARCEL
25-85-15-19-000 (0.37 Acres)

Situated in the Northwest Quarter of Section 15, T-18, R-15, Hopewell Township, Muskingum County, Ohio. Being all the lands of Asbury Chapel Church conveyed in Deed Books "T" page 36 and 83 page 229 of the Muskingum County Deed records, being described as follows:

Commencing at the Northwest corner of Section 15; thence, N.83°46'28"E. a distance of 280.50 feet along the North line of Section 15 to a found iron pin, BEING THE POINT OF BEGINNING;

Thence, N.83°46'28"E. a distance of 99.00 feet along the North line of said section to a found iron pin;

Thence, S.66°47'15"E. a distance of 93.77 feet along the lands of the Abundant Life Ministries (1658/780), to a found iron pin;

Thence, S.06°01'28"W. a distance of 43.56 feet along said Ministries lands to a found iron pin;

Thence, S.79°46'28"W. a distance of 72.60 feet along said Ministries lands to a found iron pin;

Thence, S.06°13'32"E. a distance of 13.53 feet along said Ministries lands to a found iron pin;

Thence, S.83°46'28"W. a distance of 99.00 feet along said Ministries lands to a found iron pin;

Thence, N.06°13'32"W. a distance of 107.25 feet along said Ministries lands to the point of beginning.

The above described parcel contains 0.37 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

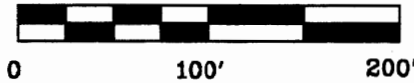

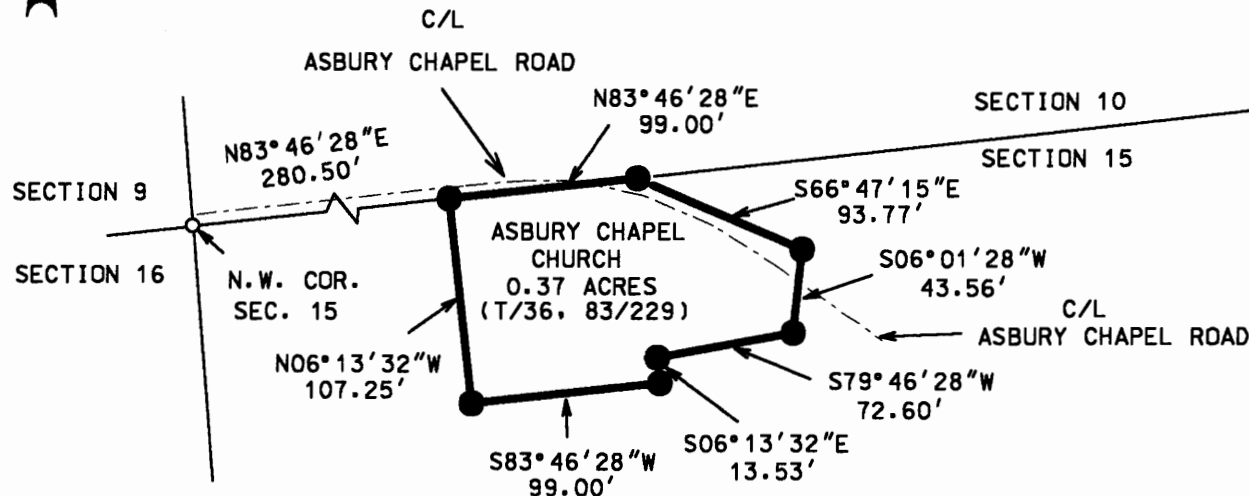
