LEGAL DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Hopewell, and being part of the southwest quarter of Section 12, and part of the northwest quarter of Section 13, Township 18, Range 15, and being part of those lands intended to be described in Deed Volume 418, page 228; being further bounded and described as follows:

Commencing at the northeast corner of the northwest quarter of said Section 13, thence, north 83 degrees – 19 minutes – 17 seconds west, 383.90 feet to the **true point of beginning** for the parcel herein intended to be described:

Thence, south 06 degrees – 40 minutes – 44 seconds west, 1986.68 feet, along the west line of those lands now or formerly owned by J. & W. Teters (536/101 and 639/174), to a twenty-four (24) inch maple tree;

Thence, north 83 degrees – 25 minutes – 30 seconds west, 840.86 feet, along the north line of those lands now or formerly owned by T. Brock (1510/479), to an iron pin found;

Thence, north 06 degrees – 49 minutes – 14 seconds east, 885.14 feet, along the east line of those lands now or formerly owned by D. Riley (1892/875), to an eight (8) inch corner post found;

Thence, continuing along said Riley lands, north 26 degrees – 53 minutes – 37 seconds west, 868.87 feet to an iron pin found at the southeast corner of those lands now or formerly owned by M. Gibson (1574/733);

Thence, along the east line thereof, north 07 degrees – 02 minutes – 03 seconds east, 362.59 feet to an iron pin found;

Thence, south 84 degrees – 46 minutes – 27 seconds east, 850.29 feet, along the south line of those lands now or formerly owned by AAB Leasing (1615/214), to an iron pin found;

Thence, south 04 degrees – 44 minutes – 12 seconds west, 513.48 feet, along the west line of those lands now or formerly owned by J. & B. Long (1145/451), to an iron pin found;

Thence, continuing along the easterly line thereof, the following six (6) courses and distances:

1. north 33 degrees – 42 minutes – 48 seconds east, 549.72 feet to an iron pin found;
2. north 01 degrees – 54 minutes – 48 seconds east, 325.75 feet to an iron pin found;
3. north 53 degrees – 02 minutes – 12 seconds west, 8.80 feet to an iron pin found;
4. north 03 degrees – 32 minutes – 48 seconds east, 144.50 feet to an iron pin found;
5. south 86 degrees – 27 minutes – 12 seconds east, 49.00 feet to an iron pin found;
6. north 22 degrees – 27 minutes – 48 seconds east, 127.44 feet to a point in the center of Coopermill Road (County Road 71), passing an iron pin found at 97.44 feet;

Thence, along the centerline of said Coopermill Road, south 66 degrees – 01 minutes – 46 seconds east, 50.35 feet to a point;

Thence, leaving said road and through the lands of H. & B. Kopchak (418/228), the following three (3) courses and distances:

1. south 22 degrees – 27 minutes – 23 seconds west, 147.25 feet to a railroad spike found, passing an iron pin found at 25.00 feet;
2. south 01 degrees – 33 minutes – 45 seconds west, 276.94 feet to a point, passing an iron pin found at 220.77 feet;

3. north 69 degrees – 45 minutes – 14 seconds east, 141.15 feet to a point on the west line of aforesaid J. & W. Teters property, from which an iron pin found bears north 87 degrees – 01 minutes – 56 seconds west, 3.00 feet;

Thence, south 06 degrees – 40 minutes – 43 seconds west, 211.55 feet to the **point of beginning**, and **containing 46.299 acres more or less**.

Iron pins set are 5/8" rebar with yellow identification cap (Finley S-7222).

Subject to all legal highways and easements, whether recorded or implied.

Bearings described herein are based upon assumed azimuth and to be used for angle purposes only.



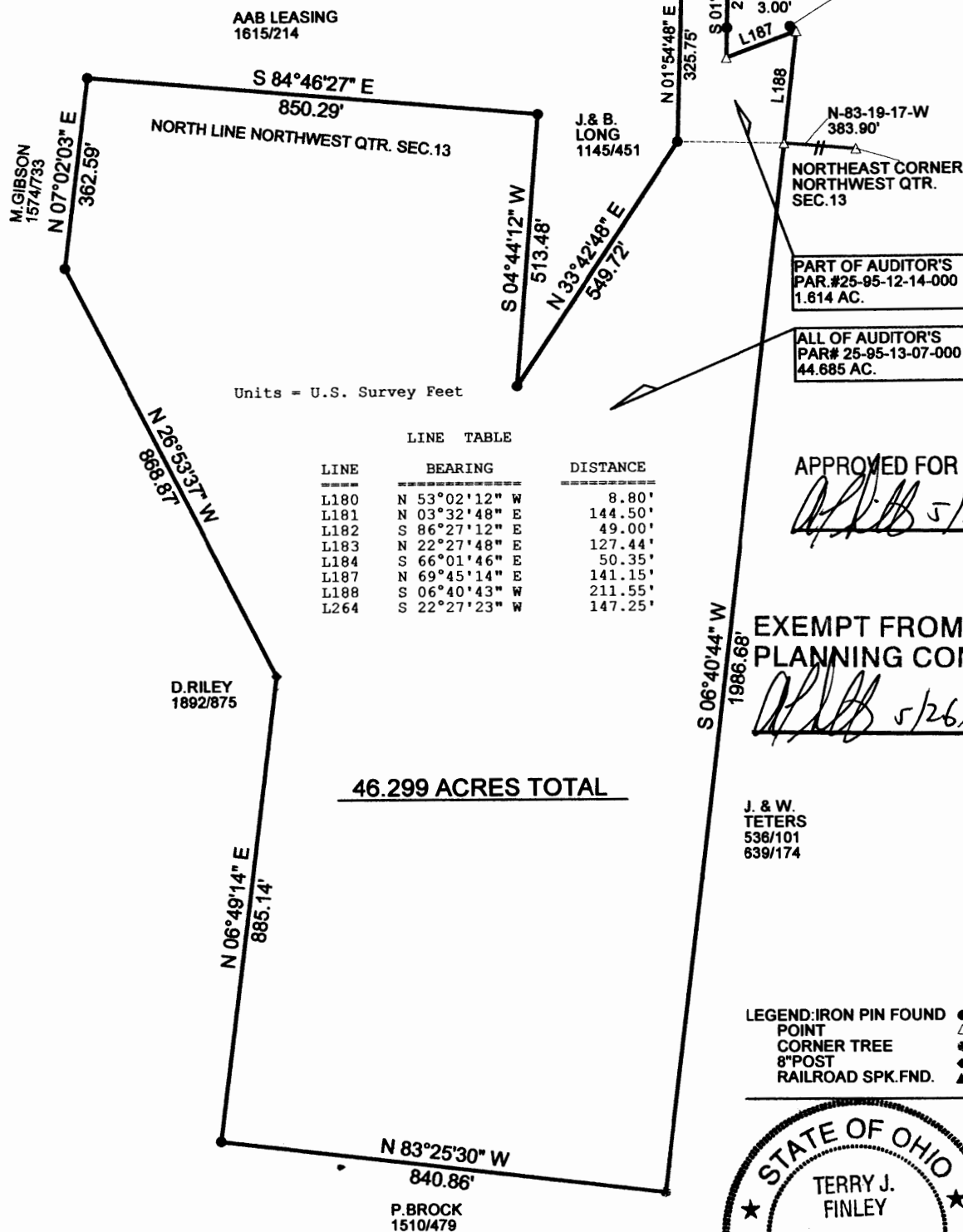
