circle; thence along a 50.00 foot radius curve to the right the cord of which

Section 13 bearing North  $89^{\circ} 26' 58''$  East.

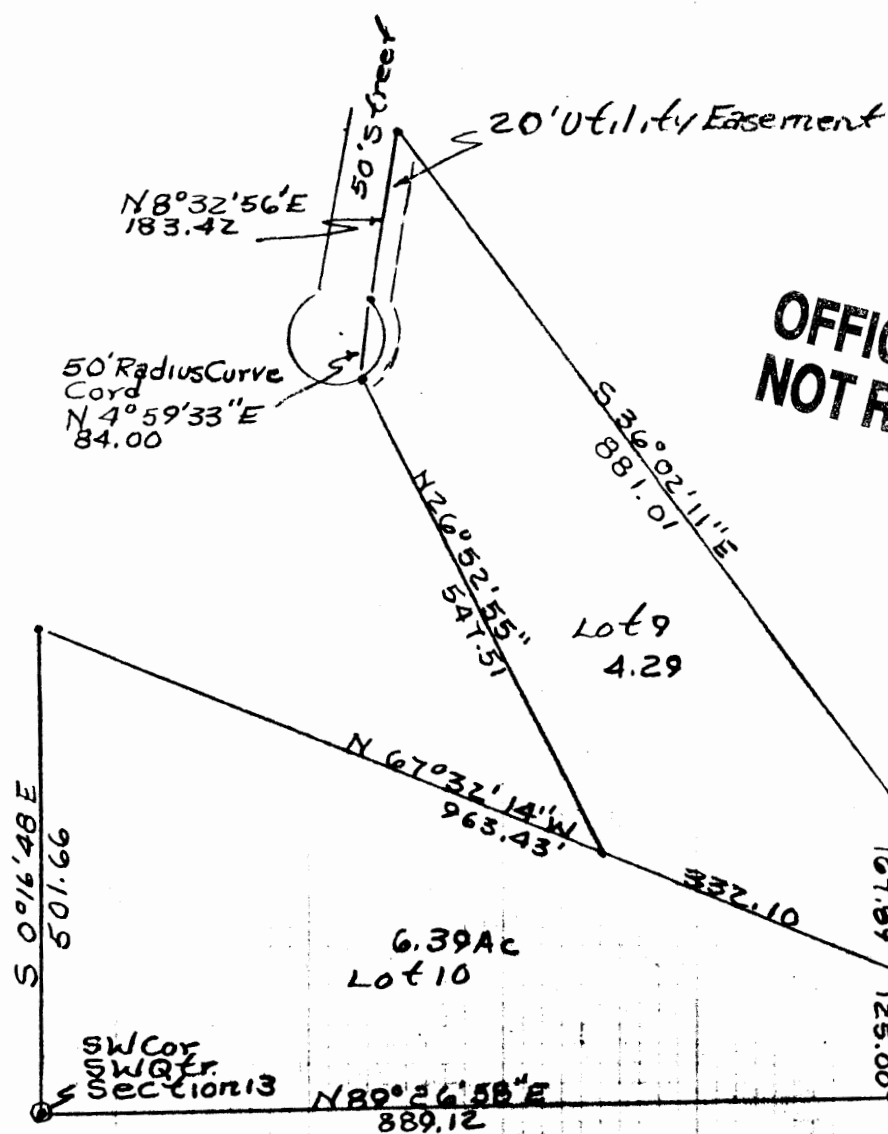
