**SURVEY DESCRIPTION
FOR
Mary White**

**PART OF PARCEL
29-20-61-11-003 (12.501 Acres)**

Situated in the West half of lot 17, Quarter Township 1, T-3-N, R-9-W, U.S.M.L., Jackson Township, Muskingum County, Ohio. Being 12.501 acres off the North end of the lands of Mary White, last conveyed in Deed Book 1120 Page 85 of the Muskingum County Deed records, and being more particularly described as follows:

Beginning at the Northwest corner of lot 17 in Quarter Township 1;

thence, **S.78°40'58"E.** a distance of **737.12** feet along the North line of lot 17 to a point on the Northwest corner of the lands of D. Williamson;

thence, **S.00°49'26"E.** a distance of **276.74** feet along said Williamson lands and along the west line of the lands of R. Lake to a found iron pipe, passing a found iron pipe at 41.41 feet;

thence, **S.04°00'42"E.** a distance of **569.61** feet along said Lake lands to a point in the center of C.R. 94 (West Carlisle Road), passing a found iron pipe at 527.43 feet;

thence, **S.42°09'09"W.** a distance of **50.00** feet along said centerline to a point;

thence, **N.56°24'40"W.** a distance of **960.49** feet through the lands of M. White (1120/085) to a set rebar on the West line of lot 17, passing a set rebar at 100.00 feet;

thence, **N.07°42'36"E.** a distance of **499.79** feet along said lot line to the point of beginning, passing a found iron pipe at 472.79 feet.

The above described parcel contains 12.501 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

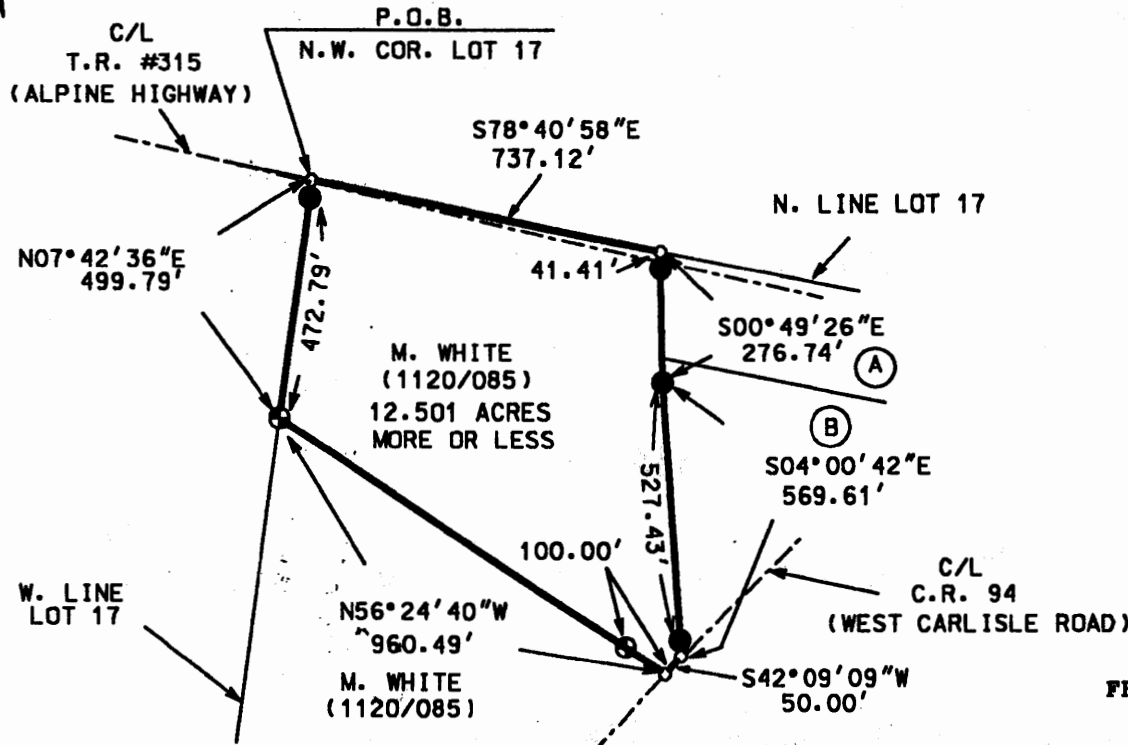
SURVEY PLAT FOR MARY WHITE
