Situated in lot #9, Quarter Township #1, T-3-N, R-9-W, Jackson Township, Muskingum County, Ohio. Being part of the lands conveyed to Donald Hindel in Deed Book 431 page 622 of the Muskingum County deed records and being described as follows:

Beginning at the Northeast corner of lot #8, located in the center of County Road #314 (Scout Road);

thence, N.83°45'15"E. a distance of 2,665.06 feet through said road and along the North line of said lot to a set rebar at the Northwest corner of lot #10;

thence, S.06°14'39"E. a distance of 784.64 feet along said lot #10 to a set rebar;

thence, S.83°45'15"W. a distance of 2,670.28 feet through the lands of D. Hindel (431/622) to a set rebar on the East line of lot #8, passing a set rebar at 2,017.35 feet;

thence, N.05°51'46"W. a distance of 784.66 feet along the east line of lot 8 to the point of beginning, passing a found rebar at 764.66 feet.

The above described parcel contains 48.052 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars. North is based an assumed meridian.

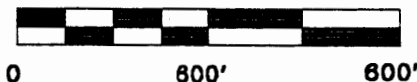

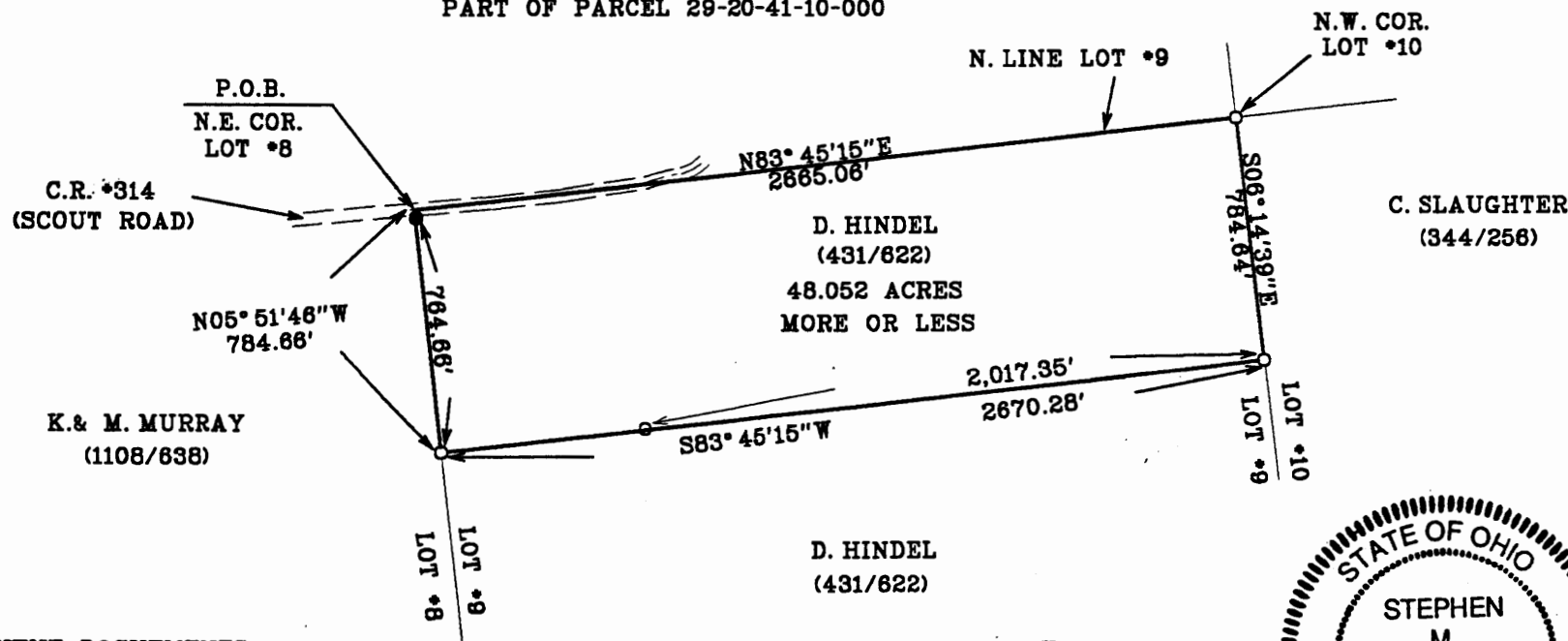
